in the registers and safe behind the bar. Outdoor seating in front of the building will be added if permitted per city ordinances/policies

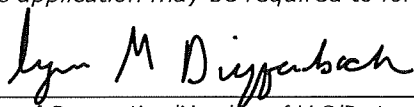
