Phair led the discussion to provide clarification on the November letter. Nichols met with the Superintendent and Reyes met with the Mayor. Nichols and Reyes reiterated the letter's intent to support the Education Committee's decision to focus on three specified topics (MOST, Community Schools and Early Childhood and Early Childhood Zones) with the understanding that other items may be added as the committee deems necessary. It was determined a revised letter was not needed and the minutes would suffice as clarification.

The Education Committee recognized that the three focus areas do not require monthly attention. The committee also acknowledged the work of organizations managing these initiatives.

Phair discussed the matrix the committee would utilize to determine priorities. The committee reviewed the items of interest listed in November 2017 using the matrix. The decision was made to continue the focus on Community Schools, MOST and Early Childhood and Early Childhood Zones. The committee further decided to focus on transportation for all kids ages 5-18 and reengaging "Opportunity Youth" as 2 additional interests to pursue. It was determined that the Afterschool program accessibility to students with special needs would fall under the purview of the MOST program. Other items of interest were reviewed and it was determined that other organizations are better equipped and currently addressing those topics.

The short-term action plan for the committee is to dedicate one meeting for presentations and a follow up meeting for discussion and strategies. Presenters will receive a detailed guide. The guide will ask for recommendations on how the Education Committee can work to assist in these areas: policy, procedures or processes, budget implications, staffing or other resources and groups currently working on the topic. The first two items discussed will be Reengaging "Opportunity Youth" and Early Childhood and Early Childhood Zones.
