During 2023, the Board of Public Works was convened for 21 meetings of which 14 included formal Assessment/Utility/Noise Impact Public Hearings.

The Citizen members of the Board were paid a salary of \$100 per annum in accordance with Section 62.14(3) of the Wisconsin Statutes.

Summary of Bids Received by the Board of Public Works Construction:

It is the goal of the City to maximize the competition for public works contracts in order to provide the best value for the expenditure of its property tax and utility rate payers. The receipt of bids from three or more prequalified contractors best accomplishes the attainment of that goal. However, the practice of the city is to open the bids for projects, which have two bidders without an extension of the bidding period.

When a single bid is received for a contract, the bid period is generally extended unless there is information indicating that there are insufficient bidders available or schedule constraints.

In 2023 a contract was considered a Best Value Contract per MGO 33.7 (7) if the contractor’s bid was equal or greater than \$74,000 for a single trade contract; or equal to or greater than \$360,500 for a multi-trade contract.

The dollar value at which Best Value Contracting requirements are applied is adjusted each year based on the change in the construction cost index as published in the Engineering News-Record.

In 2023, 59 Public Works contracts were awarded. All BVC information was not available at report time for 4 of these contracts (8595, 9086, 9326, & 9361). All BVC information is now available for 3 contracts from 2022 (8621, 8658, & 9432). Therefore, this summary of apprenticeship utilization in 2023 is based on 58 contracts, which were made up of 31 general contractors and 83 subcontractors.

Other Activities of the Board of Public Works

In 2023, the City Engineer approved 1,288 street excavation permits for main, cable, lateral, and pole locations for the Madison Gas & Electric Company, City of Madison Water Utility, Wisconsin Telephone Company, and others.

The Board reviewed various Resolutions, Ordinances, and Petitions referred to it by the Common Council regarding purchase of property, relocation orders, relocation claims, citizen complaints and petitions, official map changes, and street vacations.

The Board reviewed all Change Orders for projects which exceeded the contingency established at the time of award, exceeded \$20,000, or resulted in a change in the completion date.

Legistar : 75290

Authorizing the Mayor and the City Clerk to execute an agreement with Brown and Caldwell for engineering services for the Warner Park Watershed Study.

The City of Madison Engineering Division is conducting watershed and flood studies for the City as a result of extreme rain events over the past several years. The August 2018 historic event has highlighted the need for a comprehensive approach to Stormwater management to assist with identification of deficiencies on the system, project alternatives analysis for potential flood mitigation solutions, as well as prioritization and budgeting for future improvements to the system.

This contract will be a multi-year analysis (2023-2025). The City Engineer has advertised for consultant services for the completion of a comprehensive watershed study and report. Pursuant to City Ordinances and Policies, the City Engineer advertised for consultant proposals, reviewed the submitted proposals, and recommends the engineering contract be awarded to Brown and Caldwell. The estimated cost of the project is \$195,870.00.

Authorizing the Mayor and the City Clerk to execute an agreement with MSA Professional Services for engineering services for the John Nolen Drive Watershed Study.

The City of Madison Engineering Division is conducting watershed and flood studies for the City as a result of extreme rain events over the past several years. The August 2018 historic event has highlighted the need for a comprehensive approach to Stormwater management to assist with identification of deficiencies on the system, project alternatives analysis for potential flood mitigation solutions, as well as prioritization and budgeting for future improvements to the system.

This contract will be a multi-year analysis (2023-2025). The City Engineer has advertised for consultant services for the completion of a comprehensive watershed study and report. January 18, 2023

Legistar 75511:

Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for CIPP UV Lining Rehabilitation of Sanitary Sewers East Phase 1 - 2023.

The main goal of this project is to repair segments of the existing sanitary sewer system using UV Lining methods. In total, this project will encompass approximately 8,500 feet of sanitary sewer throughout the city's east and south sides. The estimated cost of the project is \$644,500.00.

March 8, 2023

Legistar 76501:

Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Mendota Grassman Greenway.

This project will re-grade and restore approximately 2,500 linear feet of channel and lower and increase the size of culverts on University Avenue and Camelot Drive. The estimated cost of the project is \$4,276,660.00.

March 22, 2023

Legistar 76857:

Approving Plans, Specifications, And Schedule Of Assessments For Harvey Street and Schmitt Place Assessment District - 2023.

That the contemplated purposes of this assessment district is to remove and replace the sanitary sewer, pavement, drive aprons, and to install new storm sewer, sanitary sewer, curb and gutter and sidewalk. The estimated cost of the project is \$935,000.00.

Legistar 76858:

Approving plans and specifications for public improvements necessary for the project known as 102 S Sprecher Road and authorizing construction to be undertaken by the Developer, Private Contract No. 9256.

The developer, RWW 4605 Sprecher Rd, LLC, has been conditionally approved for a one lot Certified Survey Map with one outlot at 102 S Sprecher Road. In addition to dedication of right of way for public street purposes along the Milwaukee Street and S Sprecher Road frontages, the developer shall also construction of a new north-south public street including pavement, curb/gutter, sidewalk, public utilities, and street lighting. The estimated cost of the project not to exceed \$25,500.00.

April 19, 2023

Legistar 77262:

Approving plans and specifications and authorizing the construction of Transit Network Redesign street improvements.

Metro Transit's Transit Network Redesign will restructure Madison's bus routes and schedules. The plan was adopted in 2022 and will be implemented on June 11, 2023. The work for approval is needed street infrastructure improvements to operate the routes. It consists of four projects: a minor change to the island at Highland and Regent for Route E, a new bus stop platform at Mineral Point and Gammon that is too large for city crews, about 200 feet of sidewalk and platform on the west side of Westfield Road north of Mineral Point Road, and a new sidewalk bumpout and bus stop eastbound on Badger Road at Rusk Avenue. The estimated cost of the project is \$110,000.00. Funding is available in the Metro Transit Capital budget.

May 3, 2023

Legistar 77167:

Determining a Public Purpose and Necessity and adopting Transportation Project Plat Numbers 12777-3 - 4.01 through 12777-3 - 4.11, for the required acquisitions per the Plats of Lands and Interests Required for the East-West Bus Rapid Transit - Mineral Point Road Segment project. Located along Mineral Point Road between the W Beltline Hwy on the west and S Whitney Way on the east.

The proposed resolution authorizes the acquisition of property and property rights for the construction of planned public street and station improvements for the East-West Bus Rapid Transit (BRT) project. Total right of way acquisition costs are estimated to be \$1.8m and are funded within Transportation's 2022 adopted capital budget within the E-W Bus Rapid Transit program

Legistar 77481:

Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for John Nolen Bridge Repairs - 2023.

The annual bridge inspections have identified the need for repairs on the John Nolen Drive Bridges. The repairs will consist of concrete girder end repairs, bearing bracket extension, steel wedging of bearing assemblies and steel expansion joint repairs on the pedestrian/bike path on the bridges. The estimated cost of the project is \$450,000.00.

June 21, 2023

Legistar 78072:

Approving roadway geometry for the reconstruction of John Nolen Drive from North Shore Drive to Lakeside Street.

The City of Madison and the Wisconsin Department of Transportation have proposed a project to reconstruct John Nolen Drive from North Shore Drive to Lakeside Street. No City funds required.

Legistar 78130:

Repealing and Recreating Section 16.23 of the Madison General Ordinances to Update Land Subdivision Regulations.

This proposed ordinance incorporates Complete Green Streets policies as well as codifying current best practices of land division and current statutory requirements. Additionally, this ordinance has several editing changes – including updating language to be gender-inclusive, removing unnecessary terminology and correcting statutory references. No City appropriation required.

July 19, 2023

Legistar 78780:

Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Well 15 PFAS Treatment Facility.

The proposed project will address PFAS levels in Well 15 source water by installing new treatment process equipment (pre-treatment and VOC & PFAS removal as well as chemical feed), piping and valves, controls system changes and site modifications within the existing building footprint of the Unit Well 15 facility. The estimated cost of the project is \$5,000,000.00.

September 6, 2023

Legistar 79631:

Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for State Street Campus Garage Mixed-Use Project.

The City of Madison is pursuing a new public and private development opportunity that includes the demolition and replacement of the existing State Street Campus Garage (SSCG) at 415 North Lake Street. The building project will be completed in two construction phases. Phase 1 –the Public Works project- includes demolition of the existing SSCG and new construction will include an intercity bus terminal, public parking structure, and “gray box” spaces for final build out by private Developer. Phase 2 –constructed by the Developer and not included with this resolution- will include housing components built on top and within the Phase 1 construction. The estimated cost of the project is \$55,600.00.

September 20, 2023

Legistar 79815:

Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Robin Greenway Restoration.

Phase Two of the Robin Greenway project includes native tree, shrub, native seeding, tree removals for oak wilt and tree removals identified in public engagement process, as well as ecological restoration maintenance for two years. The estimated cost of the project is \$80,000.00.

October 4, 2023

Legistar 80106:

Amending the 2023 Adopted Capital Budget of the Economic Development Division and Awarding Public Works Contract No. 8595, Madison Public Market.

This resolution authorizes the award of the base bid and alternate #3 in Public Works Contract No. 8595. The budget amendment provides sufficient budget authority to award Public Works Contract No. 8595 - Madison Public Market and complete the remaining non-Public Works project costs (i.e. design consultant fees, staff time,

furnishings/fixtures/equipment, percent for art, and related startup costs). The estimated cost of the project is \$450,000.00.

November 8, 2023

Legistar 80362:

Amending Section 8.15(1) and Creating Subsection 37.05(11) of the Madison General Ordinances to allow for certain greenway encroachments and the creation of a greenway privilege.

DRAFTER’S ANALYSIS: Under existing ordinances, most encroachments into City greenways and park lands are not authorized, even if similar encroachments may be approved on other City owned lands. This ordinance would amend Sec. 8.15(1) to create a limited exception to this prohibition and allow for some encroachments into greenways that are solely managed by the Engineering Division, including lands managed by the Stormwater Utility (such as ponds and other detention basins). While gardens and temporary fencing may be allowed with notification and approval of the City Engineer, more extensive encroachments, including permanent fencing, retaining walls, stairs, outbuildings, hardscape and parking areas would require the granting of a greenway privilege under the newly created 37.05(11). A greenway privilege would be similar to a privilege in street under Sec. 10.31, and would be within the discretion of the City Engineer to grant. The City will retain the ability to remove any greenway encroachment that interferes with City operations or that presents a risk to the public health, safety and welfare. The estimated cost of the project is \$17,001,100.00.

November 20, 2023

Legistar 80605:

SUBSTITUTE - Approving geometry, plans, and specifications and authorizing the Board of Public Works to advertise and receive bids for Mineral Point Road Widened Sidewalk.

The Mineral Point Road corridor currently has established yet deficient accommodations for cyclists. To resolve poor bicycle accommodations the Bus Rapid Transit project will widen the established north sidewalk to accommodate multiple types of users. The widened sidewalk is part of the Bus Rapid Transit project negotiations and agreement with the Federal Transit Administration, receiving federal funding for its construction. City Transportation and Forestry staff, in coordination with consultant staff, have developed a geometry that preserves trees while still providing a protected all ages and abilities facility for different types of users. The estimated cost of the project is \$7.375 million. Funding is available as part of the overall Bus Rapid Transit project.

Street and Path Condition Report

The City of Madison Engineering Division rates half of the paths and streets every year to maintain a comprehensive understanding of the condition of our pavements. The City uses the PASER rating system, a pavement management rating system developed by the University of Wisconsin Madison Transportation Information Center. The PASER system utilizes a scale of 1 to 10 with 10 being a new pavement and 1 being a poor pavement.

For an asphaltic and concrete streets, a 3 rated street requires reconstruction or resurfacing within the next few years. We have set the following goals for streets:

Pedestrian and bike paths differs in that surface defects are less tolerable. A rating of 5 or below is ideally scheduled for resurfacing or reconstruction within the next few years.
