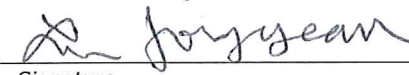

Underage persons are allowed within the restaurant space during regular hours. No one under the age of 21 will be permitted to consume alcohol on the premises. Any Fake IDs presented will be confiscated and turned over to MPD as needed.

Plan to control and supervise patrons under twenty-one (21) years of age: _____

Patron's IDs to be checked by bartenders and servers upon request of an alcoholic beverage (premise operates as a full service restaurant). Underage persons are not permitted to be served alcohol and groups will be asked to leave if observed providing an alcoholic beverage to an underage person. No one under the age of 21 will be permitted entry after 9:30pm

(Samba Brazilian Grill hours) or as approved by Management during a scheduled private event (typically for weddings, etc.)

How will orderly appearance and operation of the premises be maintained in regard to litter and noise:

Full staff is on hand every day to perform cleaning and general maintenance duties of the interior and exterior of the building.

Limited amplification of live instruments, vocals or recorded music is allowed, with the intent of providing a level of noise sufficiently low so as to allow for conversation between patrons at all times.
