Re: Girl Scout 100th Anniversary Event on May 5, 2012

On March 12, 2012, Girl Scouts of the United States of America will celebrate their 100th Anniversary. During the spring of 2012, three Girl Scout councils in Wisconsin will be holding three separate events to celebrate this important milestone.

Our council, Girl Scouts of Wisconsin – Badgerland Council (GSWIBC), is headquartered in Madison. Our jurisdiction reaches across south-central and southwest Wisconsin (21 counties) and includes parts of Illinois, Iowa, and Minnesota (1 county in each state). We currently serve 13,500 Girl Scouts and are growing! We are planning a large celebration event for the weekend of May 5-6, 2012. The participation goal of this event is 5,000-10,000 Girl Scouts, Girl Scout supporters, and Girl Scout Alumnae from across the state gathering together in Madison to celebrate the past 100 years and looking ahead to the next 100 years. As part of this celebration, we want to bring our message of leadership and community service to the Capitol Lawn and to spread the message of building our future leaders through the Girl Scout Leadership Experience.

We are finalizing plans with the Alliant Energy Center, where we will be gathering to kick off the event as well as spend an overnight following our march. Registration and festivities will begin at Willow Island starting at 12:00 PM on Saturday. While we are gathering, we are going to have entertainment and speakers to get the crowd into the spirit of Girl Scouting.

By 2:00 PM, we will have broken the participants into several large groups and will begin to release the groups to walk up John Nolan Drive toward the Capitol. We will be organizing the groups with the goal of everyone arriving at the Capitol together. Participants will be carrying signs and messages about all of the great and exciting opportunities Girl Scouting provides. We will also be celebrating Women's History milestones along the way.

Along the route of the walk, we will have stations providing short refreshments (water, snacks) but also brief learning stops. An example of one of these stops would be a group of adults dressed up in historical Girl Scout uniforms from the past 100 years. It would be very easy to take a short break for water and learn about Girl Scouts' and women's history along the way. These stops would be stationed in the green space along the bike path on John Nolan Drive. We anticipate set-up of these stations to begin at 12:00 PM.

We estimate that the first of our girls and supporters will arrive at the Capitol grounds at approximately 3:00 PM. Starting at that time, we will have scheduled activities going on along the square. Some of those may include short service-related projects, exhibitor booths, or activities provided by some of our program partners, and refreshment or concessions. We would also like to

provide our crowd with scheduled speakers and a Girl Scout Bridging Ceremony on the steps of the Capitol. This event provides a unique opportunity to give the girls and women of the State of Wisconsin a ceremony and event they will never forget.

At 5:00 PM, we will begin transporting our crowd back to the Alliant Energy Center by chartered bus. All of the transportation should be completed by 6:00 PM.

After the crowds have been transported back to the Alliant Energy Center, we are planning several other events to fill the evening and overnight hours. We will be completely vacating the Alliant Energy Center at 10:00 AM on Sunday the 6th of May. We anticipate a smaller number of participants at the overnight portion of this event than we do for the activities during the day.

The 100th Anniversary of the Girl Scouts provides us, as a youth organization, a very unique opportunity to celebrate as well as showcase all of the good works our girls and volunteers do. We expect the thread of leadership, service, and Girl Scout pride to weave through all aspects and activities related to our event.

We are very much looking forward to this exciting and once-in-a-lifetime event. As we have shared the message of what we are planning, we have received numerous positive responses from our fellow Girl Scout councils, our volunteers, girls, alumnae, and funders. Our goal is that this special anniversary event will make a significant impact on the lives of all who participate. In order to do so, we will provide a safe, well-organized, and efficiently run event.

We look forward to meeting with you and discussing this event in detail.
