Dear Stuart: A copy of the proposal is enclosed for your review.

I am writing this on behalf of the Madison Public Library Board, of which I serve as President, in connection with the proposal to renovate and reconstruct portions of the 100 Block of State Street.

Since this proposal would substantially renovate and update, particularly the Fairchild/E. Mifflin Street aspect of the block, this proposal was of great interest to the Board. As you no doubt know we are in the process of a significant renovation and expansion of the Central Library to create a world-class urban library space at the current location of Fairchild and Mifflin. When finished, this will be a wonderful and exciting addition to the central city. Thus, the board members have even more interest in matters that affect adjacent and nearby properties.

In the late fall of 2011, we received an informational presentation from the representatives of the 100 Block Foundation, including the architects. Following that presentation, at its meeting on November 3, 2012, the Board went on record in strong support of the project. I enclose a copy of that resolution which was adopted unanimously at the meeting in November.


It is my understanding that the proposal has undergone some modifications since that time, but none of those proposed modifications have diminished our support for this renovation. The Fairchild/E. Mifflin aspect of the project will, indeed, be the "front porch view" from the new Central Library and we think the proposed redevelopment will be


