4. Q2326 Authorizing the execution of a Utility Easement to Wisconsin Bell d/b/a SBC Wisconsin across a City-owned property located at 1903 E. Washington Avenue. 6th Ald. Dist.

7. <u>02502</u> Authorizing the Mayor and City Clerk to execute Addendum No. 1 to the Contract For Subdivision Improvements for Nelsons Addition to Rustic Acres, Contract No. 2041. (3rd AD)

Van Rooy, to RECOMMEND TO COUNCIL TO ADOPT - REPORT OF OFFICER Mike Dailey, City Engineering, reported that this addendum is to allow the developer to formalize lot line elevations and allow release of building permits prior to grading to approved lot elevations. This addendum shall guarantee establishment of these grades. The motion passed by acclamation.

A motion was made by Mr. Rewey, seconded by Mr. Harrelson, to RECOMMEND TO COUNCIL TO ADOPT - REPORT OF OFFICER. The motion passed by acclamation.

13. Change Order No. 1 to Contract No. 5825, Valley View Road Sewer & Drainage, to Hammersley Stone in the amount of \$13,376.00.

Alder Van Rooy moved approval; Mr. Elmakias seconded; Unanimously passed

14. Change Order No. 2 to Contract No. 5850, Goodman Community Pool Construction, to Joe Daniels Construction Co., Inc. in the amount of \$71,865.66.

Alder Van Rooy moved approval; Ms. Hewitt seconded; motion passed with Alder Palm voting NO and Mr. Rewey abstaining. Mr. Rewey stated he wanted more information on the change order.

15. 02154 Petition: Notice of Appeal - Prohibited Use of Public Greenway.

A motion was made by Mr. Rewey, seconded by Mr. Elmakias, to RECOMMEND TO COUNCIL TO DENY - REPORT OF OFFICER

Jessica Long, Assistant City Attorney, distributed to the board a copy of a letter sent September 12, 2005, to Rhonica Lemanski, of 7325 Blue Maple Trail, regarding prohibited use of City greenway. A copy of MGO 8.15, Regulation of Private Use of Greenways and Park Lands, was also distributed. The board reviewed the letter and ordinance.

Kathy Cryan, City Engineering Division, briefed the board on contact with the residents at 7325 Blue Maple Trail. She stated the Engineering Division discovered landscaping materials being stored in the greenway in October of 2003. On October 21, 2003 a notice regarding the prohibited use of greenway was sent to Rhonica Lemanski.

On September 21, 2005 a notice regarding the prohibited planting of five large trees about 15 feet into the City's greenway on the backside of 7325 Blue Maple Trail, was sent to Rhonica Lemanski.

Troy Raegels addressed the board. He stated he was a co-owner of 7325 Blue Maple Trail, and had spoken with Mike Dailey, City Engineering, regarding planting trees in the greenway. He said he had been advised by Mr. Dailey to submit a sketch to the Engineering Division of proposed plantings and their locations. Mr. Raegels said he had done so, although he could not recall to whom the materials had been submitted, nor could he provide a copy of the sketch for the board. He said he never received a response from the Engineering Division and had progressed with his plans because of a deep concern for the environment.

Mr. Dailey said he recalled the conversation with Mr. Raegels but did not receive a sketch and added that per established procedure, Mr. Raegels would also have been advised that a written permit is required prior to the trees being planted.

Ms. Cryan also stated she did not receive a plan or approved permit for the trees to be planted.

Ms. Hewitt commended Mr. Raegels for his environmental concerns and said she hoped he would contribute his energies to an organization working to protect the environment. She however cited the primary purpose of a greenway is for stormwater conveyance and the species of trees planted are in direct conflict with this purpose.

The motion passed by acclamation.

16. 02495

Authorizing the Mayor and City Clerk to execute an agreement between the City of Madison and MB Investments of Wisconsin, LLC for indemnification for snow plow damage for lots 126-153 of the plat known as Linden Park. (6th AD)

A motion was made by Mr. Rewey, seconded by Mr. Elmakias, to RECOMMEND TO COUNCIL TO ADOPT - REPORT OF OFFICER Rob Philips, Deputy City Engineer, displayed the plans and reported that this agreement will indemnify the City for snow plowing damage for lots 126 - 153 for the plat known as Linden Park. These lots will take access from a narrow alley. It was noted for the record this is the Ninth Aldermanic District rather than the Sixth Aldermanic District as noted on the agenda. The motion passed by acclamation.

Board reviewed a listing of contractors requesting to be qualified to bid City projects; and/or be licensed as concrete layer, asphalt paver or mudjacker. No appeals to the process.

19. Awarding Public Works Contract for Bids Opened December 2, 2005 and December 16, 2005.

Rewey/Harrleson approved low bid of Sun Prairie Sand & Gravel, LLC. \$494,775.00.

20. Change Order No. 1 to Contract No. 5855, Heating Hot Water System Modifications at Sayle Street to H & H Industries, Inc. for a contract time increase by 135-days (135-days from 1/16/06).

Alder Palm moved; Mr. Elmakias seconded; Motion unanimously passed.

Jim Whitney, City Architect, explained that due to funding difficulties, the project was delayed for two months.

21. Change Order No. 5 to Contract No. 5609, Howard Place Reconstruction Assessment District 2004, to Henshue Construction in the amount of \$270.00.

Ms. Hewitt moved; Mr. Elmakias seconded; Unanimously passed.

Approving a "Major" Change to Amend the Environmental Corridor within the Central Urban Service Area of Dane County for the Property of 5513 Femrite Drive (et al). (16th AD)

A motion was made by Ms. Hewitt, seconded by Mr. Elmakias, to RECOMMEND TO COUNCIL TO ADOPT - REPORT OF OFFICER. The motion passed by acclamation.

23. Q2547 Authorizing the Mayor and City Clerk to enter into an agreement with Madison Gas & Electric Company for the undergrounding of overhead utilities in conjunction with the Todd Drive Beltline Highway Interchange project. (14th AD)
