TO: Property Owners near Nakoma Road and Manitou Way

RE: Proposed Storm Sewer Installation in conjunction with the Shawnee Pass Reconstruction Project

You have previously received notification about the Shawnee Pass Reconstruction project that will be presented to the **Board of Public Works on January 29, 2024, at 5:30pm**. Please be aware that this project also includes work on Nakoma Road and Manitou Way for the replacement of a large storm sewer box culvert. Project details are provided below. This is additional notification for those potentially impacted in the storm sewer project.

Project Description:

In 2024, it was discovered that the storm sewer box culvert that extends from Nakoma Park to the pond within the Arboretum was failing under the roadway. The City will be replacing portions of the failing storm sewer in conjunction with the Shawnee Pass Reconstruction project.

The new storm sewer box culvert will be replaced with a larger sized pipe that is in keeping with the Wingra West Watershed Study flood mitigation recommendations. For more information on the Proposed storm sewer

The storm sewer replacement is **not** assessable; however, there will be impacts to traffic on both Nakoma Rd. and Manitou Way. This work will be completed in the summer of 2025.
