AUTHORIZING ACCEPTANCE OF A GRANT AND APPROVAL TO ENTER INTO AN AGREEMENT WITH THE WISCONSIN DEPARTMENT OF CHILDREN AND FAMILIES (DCF) FOR THE MATERNAL, INFANT, AND EARLY CHILD HOME VISITING (MIECHV) PROGRAM TO SUPPORT THE

Policy Analysis Statement:

Brief Description of Proposal -

MIECHV funding would support growth of the Nurse Family Partnership program within Dane County by supporting the creation of a 1.0 FTE public health nurse and continuing funding the Maternal Child Health Navigator position that was created in 2015 with MIECHV funds. Funds would also support professional development and program support fees. Funding cycle is 10/1/16 through 9/30/16.

Current Policy or Practice -

PHMDC currently administers Nurse Family Partnership within Dane County; it is entirely funded through GPR.

Impact of Adopting Proposal -

MIECHV funding would support growth in staffing, expanded reach, and improved systems for outreach and enrollment of eligible women into the program.
