I am urging you to continue supporting Jenie as the recommended artist. Please do not send this project back to the Common Council, who already approved Jenie as the vendor in 2022. Please support one of the many solutions that Jenie has provided to make this project feasible in 2025-2026.

And most importantly, I sincerely hope Jenie will be compensated for her work on the project so far, no matter what steps the city takes next. As a musician, I know from experience how many hours of preparation go into a project before it is presented to an audience. It would be a mistake for the Madison Arts Commission to not recognize this labor.

Dear Commission members and Karin Wolf:

As a lifelong resident of Madison, I have been so grateful for the role that Public Art has been playing in our community for some time. I have great respect For Karin and her efforts and that of the Arts Commission. I was so sad to learn that because of some needed work on the Madison Metro building the planned Public Art on that facility has been pushed into the future for some significant time. I know there was great enthusiasm for the competition that resulted in the selection of Jenie Gao. I thought all the artists were excellent, and Jenie was my favorite.

I am concerned about the long-term impact of decisions the City of Madison and the Madison Arts Commission may be making. I believe the competition on this project came from artists of great reputation and from places far away. If Madison becomes known as an entity that does not live up to his contracts with artists in the same way it would hopefully stand by all its legal obligations, we might not have such a diverse submission group in the future. More importantly, at this time, I believe we have an obligation to the contracted artist, who has already invested time and travel and other expenses for which she may now be out-of-pocket. I've been told she has over 300 hours into the plan and has hired outside advisors. It took 18 months for her to get a contract that she could sign. I ask that the City keep its agreement with Jenie Gao and work with her on elements that might need changing. The City Council already approved her after many public interactions where many of us stated our support of her. To make any changes now would be a disservice to those who take time to give public input and to those artists who share their gifts with us.

I would sincerely hope that MAC can advocate for artists as it so often does and this artist, in particular. We will cause her personal harm and I believe influence how other artists view us as an entity going forward. And the lack of support and helping this artist work out a solution that is favorable to all will send the opposite, much more positive message.
