82968 Presentation to Retiring Board Member, Jane Richardson: Judy Karofsky,
 Chair

This is the last meeting Jane Richardson will attend as a board member, her term expires May 1, 2024. Jane has a long history with Monona Terrace going back to Paul Soglin's second administration, when the city was deciding whether to build the convention center. One of Jane's contributions to the center was to suggest that the city include "community" in the name. Hence the moniker Monona Terrace Community and Convention Center and this underscored the mandate of the building to be a community gathering place. She was appointed to the board during Paul Soglin's third administration on May 1, 2012 and contributed greatly by serving on four committees: the Operations/Marketing Committee, Strategic Planning Committee, Judge Doyle Square Ad Hoc Committee and the Nominating Committee (for which she chaired 3 yrs). The board appreciates her 12 years of service.
