President of the Park Commission

President Emily Gnam noted that item 11 was removed from the original agenda so any registrants for that item would no longer need to stay.

Superintendent of Parks

Parks Superintendent Eric Knepp described the situation with the boathouse that has been mooring near the boat launch at Marshall Park. The owner has been told this is not allowed and has been ticketed repeatedly. The owner does not have a plan to remove it before the lake freezes so Parks requested and received authorization by Common Council to remove it. The contractor is set to remove it tomorrow and Parks will attempt to recover costs from the owner. Clean-up at Reindahl Park will continue, as nearly all people at the encampment have left. Knepp reminded the commission that no machine-made snow will be made at Elver Park this year as it's not budgetarily responsible at this time. Parks hopes to partner again with MadNorski in the future. Warming shelters at the skating rinks will remain closed this winter due to operations staffing and continued COVID concerns. Parks will continue to evaluate. Due to warm temperatures, ice rinks are unlikely to be ready until January.
