
1. The undersigned is the sole owner of the Attachment Parcel.

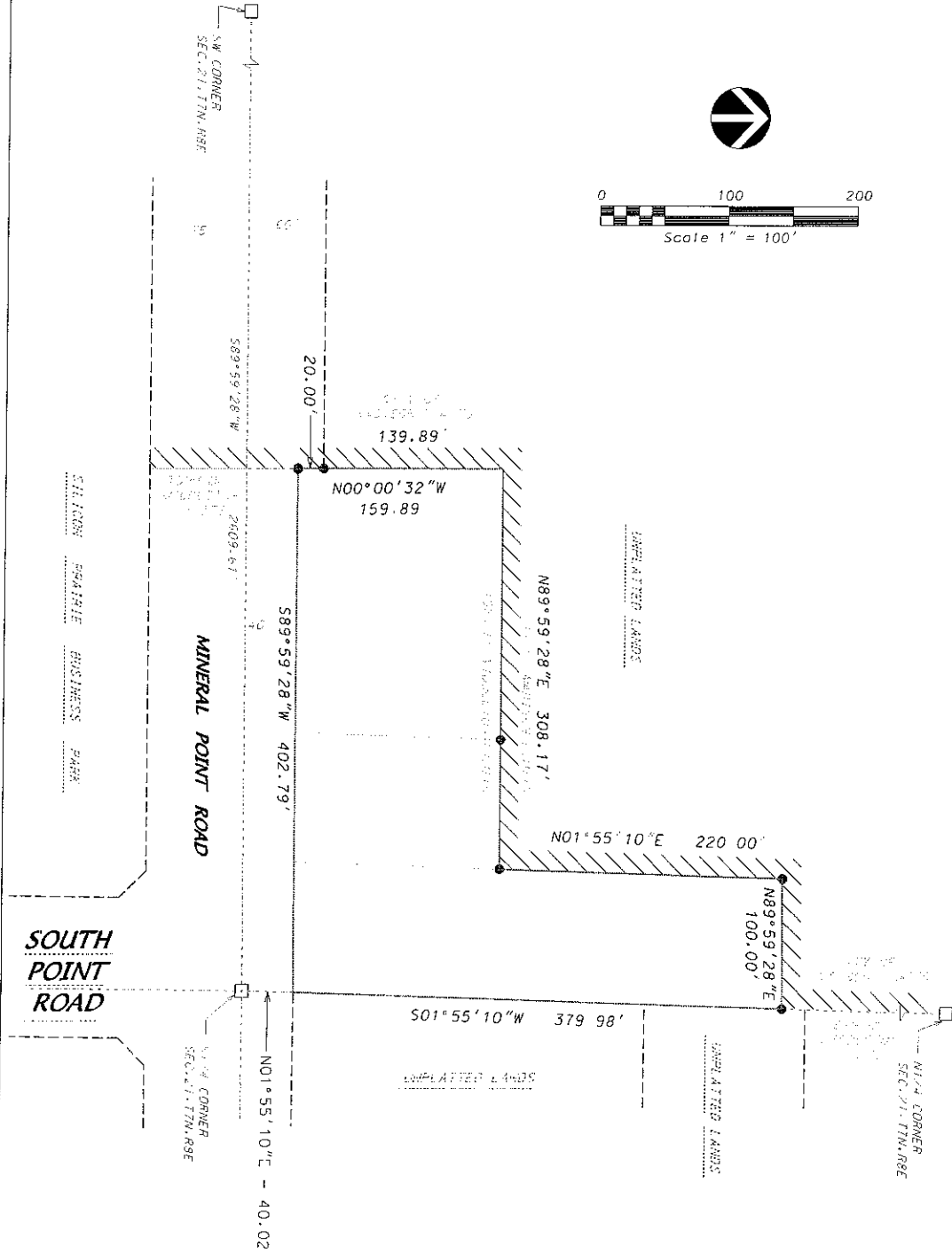
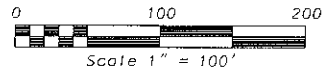
Legal Description
