SUBJECT: 2009 Second Quarter Traffic Enforcement Activity Report

(April - June)

The information provided herein represents the Madison Police Department's traffic enforcement activity for the second quarter of 2009. It should also be noted that during this period, a position remains vacant on the Traffic Enforcement Safety Team due to the retirement of an officer earlier in the year.

In summary, all traffic citations issued for the second quarter of 2009 totaled 7,349 (5,398 citations for hazardous violations and 1,951 citations for non-hazardous violations). Additionally, 812 traffic warnings were issued. Of these totals, the Traffic Enforcement Safety Team (T.E.S.T.) issued 2,115 citations (1,791 hazardous citations and 324 non-hazardous citations). This reflects a **42% increase** in the issuance of overall citations department wide and a **136% increase** in the issuance of overall citations by the Traffic Enforcement Safety Team, when compared to second quarter data from 2008. The 2009-year to date department citation total is 13,395 in comparison to 9,680 citations issued during the same period in 2008, which represents a **38% increase**.

Included in the above data are 3,085 speeding citations issued department-wide during the second quarter of 2009, which reflects a **73% increase** when compared to 1,779 citations issued in the second quarter of 2008. Also included in the department-wide citation totals were 13 citations issued to pedestrians and 6 citations issued to bicyclists for various violations and 63 citations issued for motorists failing to yield to pedestrians.

The significant increase in citation activity is attributed to several factors that were identified in the 2009 first quarter report, which continued in the second quarter. These factors include increased staffing department wide which has allowed officers more time to do pro-active enforcement, additional enforcement funding through state grants, a more structured enforcement approach involving TEST, patrol and CPT officers that focused on addressing District traffic issues, as well as officers and supervisors continuing to recognize this as a department and community priority.

The Traffic Complaint Hotline (previously known as the Speeders Hotline) received 266 citizen calls during the second quarter of 2009, resulting in the mailing of a total of 150 warning letters. In addition, Crossing Guard observations resulted in 286 warning letters being mailed and 33 citations issued. Complaints involving the Boom Car Ordinance resulted in the issuance of 11 citations and 5 warnings letters during this period.

Within the second quarter of 2009, traffic enforcement overtime grant initiatives were scheduled. These grants were coordinated through the Department of Transportation, Bureau of Transportation Safety. Impaired driver (OMVWI), excessive speed and pedestrian safety enforcement initiatives were conducted during this time period resulting in the issuance of 783 citations and 89 warnings, and included 18 physical arrests for OMVWI (impaired driving). This activity is reflected in the Department citation totals.

In the second quarter of 2009, Traffic Specialists investigated 9 significant traffic crashes. Of those, 2 crashes involved serious injuries and 7 crashes resulted in 8 fatalities. Alcohol was a factor in 7 of the crashes during that period.
