**REPORTS****President of the Park Commission**

Opening of The Glen Golf Park this past Sunday went really well, looked to be well-attended and had good coverage. Doug Moe's article was a nice way to tell the story of the park. Gnam expressed appreciation to the Madison Parks Foundation for making it happen. They and Parks have done a great job. Welcomed Catie McDonald Shannon to the Park Commission. Summer is a good time to be in parks. Forward Madison is having a good season. The June 13th storm damaged many trees across the city, asked Superintendent Eric Knepp to make some comments regarding the storm and the tree damage. Explained subcommittee assignment changes and shared that Madelyn Leopold will be ending her tenure with the Park Commission by the end of the year and expressed gratitude towards Madelyn's service.

Alder Abbas inquired about exploring condensing the subcommittees in the next 2 or 3 months. There should be discussion about the impact of ending some of them, exploring benefits, and unintended consequences.

Knepp and Miller Fienen provided a brief update regarding the Lake Monona Waterfront competition and encouraged Commissioners to engage in the selection of firms. LMW is on an aggressive schedule to meet the John Nolen Drive project timeline in order to be able to secure federal funding for the project. Assistant Superintendent Lisa Laschinger provided a brief update regarding the reopening of The Glen Golf Park Grand Opening went well with approximately 800 in attendance.

Glenway Woods Master Plan Update

Freiwald introduced the project and provided a brief summary of the process, including applying for a grant from National Parks Service through Rivers Trails and Conservation Assistance Program for area that has not officially had a plan or been classified as a specific use type. Introduced Mike Mencarini from NPS who provided an overview of the services and support that will be provided to the Parks Division and the project.

Renaming of Kerr-McGee Park

Knepp presented the request from Olbrich Botanical Society & Madison Parks Foundation to rename Kerr-McGee Park. It does not appear the parcel was ever formally named Kerr-Mcgee. R. Richard "Dick" Wagner was part of a team that advocated for park land and was a dedicated volunteer that cared for the park. Mr. Wagner was a major contributor to OBG and an icon in the LGBTQ+ community both, including documenting the community through various stories he authored. The Parks Long Range Planning Subcommittee recommended Park Commission approval of renaming at their last meeting.

Alder Michael Verveer sent his regrets. He was unable to attend tonight, but strongly supports this request.

Motion made by Leopold, seconded by Abbas, to Approve the Renaming of Kerr-McGee Park to R. Richard Wagner Park. Motion passed by voice vote/other.

An official naming ceremony will be held in late September, near Dick's birthday.

Mr. Ed Jepsen was a strong leader in the improvement of the Yahara River Parkway bike path, including the bridges under East Johnson Street. The name "Ed Jepsen Way" is at the request of the requesting committee to speak towards Mr. Jepsen's way of living. He was very involved in Parks Long Range Planning for many years and was influential in a number of existing key policies. Former Parks Assistant Superintendent Kay Rutledge reached out to voice support of this request. He also played a key role in the Dog Park policy. The Parks Long Range Planning Subcommittee recommended Park Commission approval of renaming at their last meeting.
