2. <u>08272</u> Garden/CAC Reports

Plot Fees: there has been a small push back as to paying the lowest amount as a protest. Free soil for possible use at Demetral (on landfill) is available from City Of Middleton dredging project. There is also discussion of a possible garden in Brittingham Park to address social dynamics there. The St. Paul Garden is now under State jurisdiction and it (along with possibly Atwood) are slated for high-speed rail use eventually. There will be a Water Utility update possibly at the next meeting. CAC also went through a HUD audit of a recent grant and received 100% clearance. Longtime CDBG Grants Supervisor Hickory Hurie has announced his retirement and will be missed.
