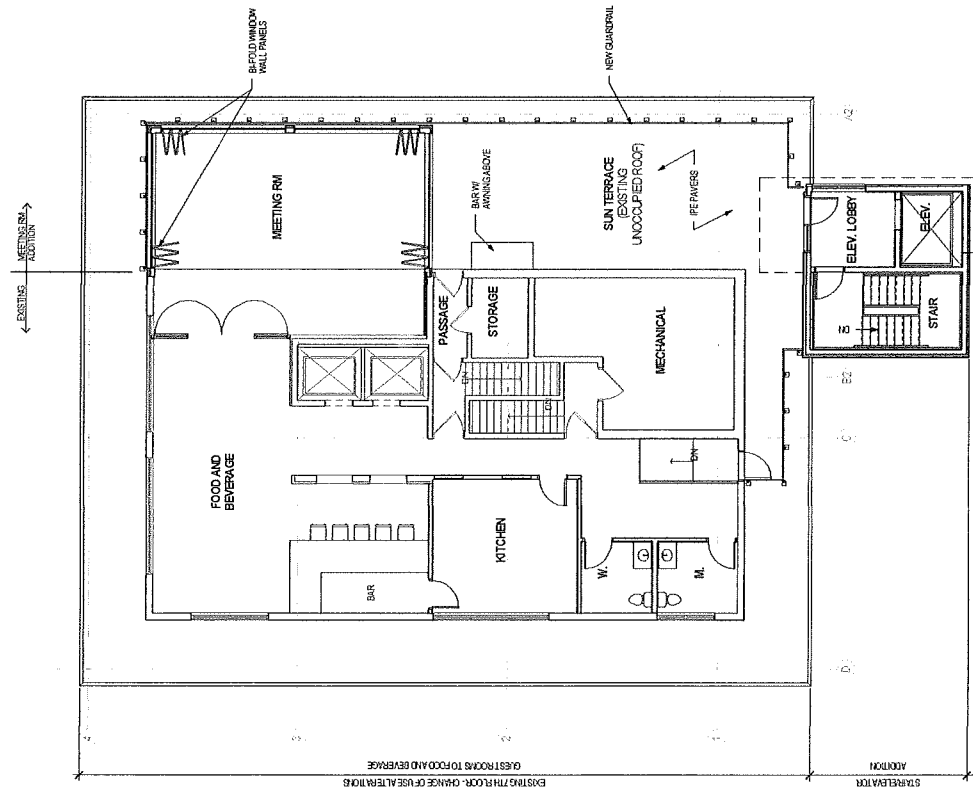

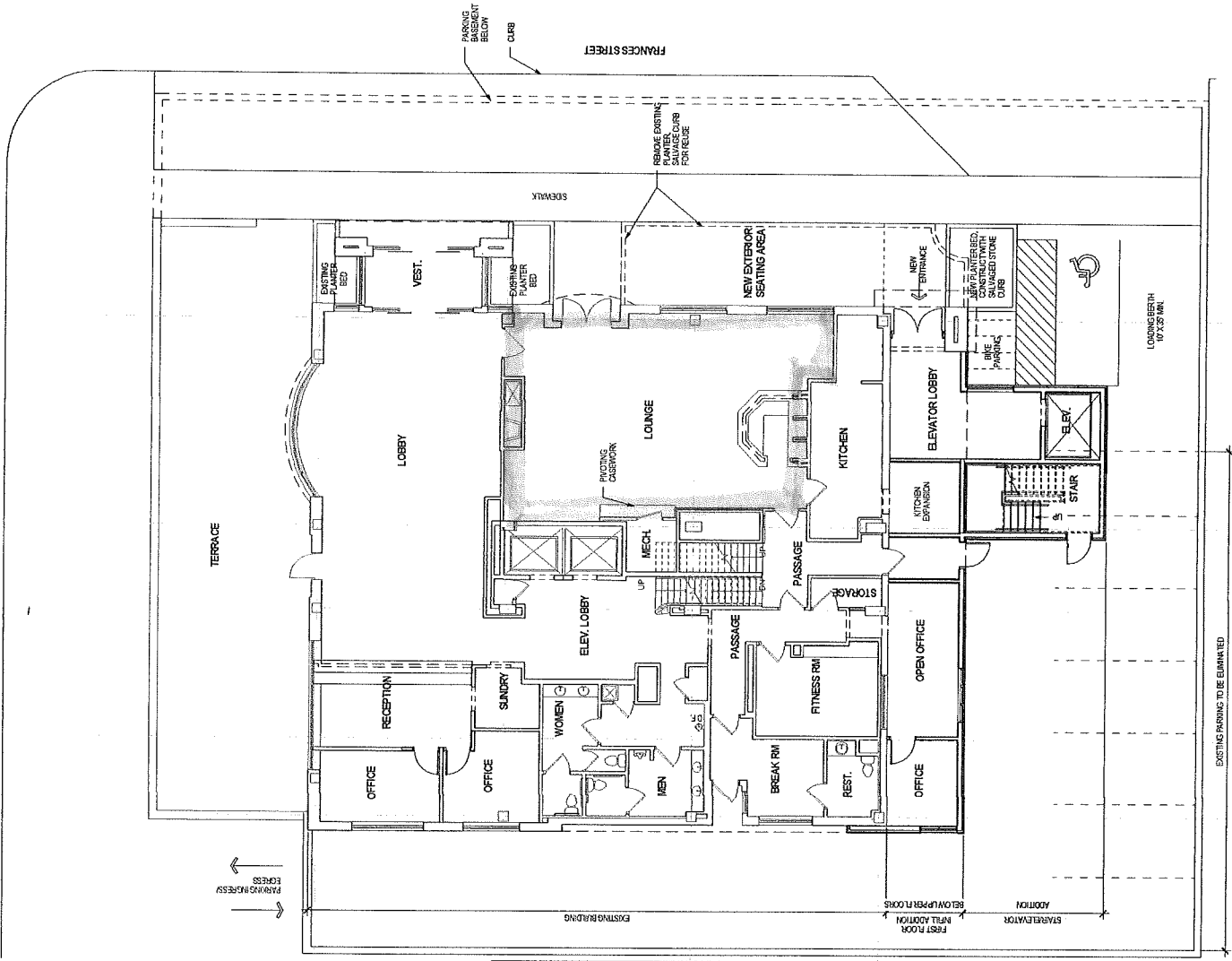
1 FOURTH FLOOR PLAN (5 & 6TH FLOOR SIMILAR)
