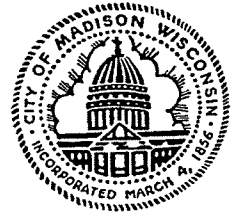

PURSUANT TO SECTION 38 OF THE MADISON GENERAL ORDINANCES AND CHAPTER 125 OF THE WISCONSIN STATE STATUTES.

Premises: 1,200 sq. ft. restaurant including bar/lounge, seating area, service area, kitchen and bathrooms. Walk-in cooler for beer and locked cage for alcohol storage in the basement.

Common Council granted 4.18.2017 with the following conditions:

1. The capacity shall not exceed 80 persons indoors and not exceed 28 persons in the sidewalk cafe.
2. Must meet the definition of a restaurant as defined by MGO Section 38.02.
3. Alcohol service shall cease at 11:00 pm Sunday through Wednesday and cease at 1:00 am on Thursday through Saturday.
