Hotel occupancy is on an upward trend for the downtown and the greater Madison area. It's not yet met 2019 levels. Room rates however, are above 2019 levels, with Downtown hotels leading in that area. The 5 year booking pace is on track for 2024 and 2027, but soft for 2025 and 2026. The DM sales team is

prospecting for clients that fit the right criteria and are looking for space in 2025 and beyond. Surprisingly, there are still many groups making 2024 bookings. In projected room nights for 2023 they have nearly met their goal in definite room nights, and if the tentative room night's contract they will exceed 95,837, the historical average. DM has \$228,979 in contracts out for Monona Terrace business so far this year (not including 2 additional contracts picked up in May)

In sports news, the city will be getting a pro volleyball team and potentially a women's pro soccer team. Having these teams will boost Madison's reputation as a sports town and will increase travel to Madison. In addition, the sports feasibility study has been completed. The results can be shared out to any who request it.

There was a question regarding how sales staff identify and qualify a prospective customer. Through use of a comprehensive database that they continuously add to, they can search for groups using a variety of filters (size, event type, timing, etc.) Then make contact with the groups that meet the specific parameters they are looking for. The time from first contact to signed contract can take a really long time, literal years in some cases and require constant connection.

As reported in the paper the Committee has chosen Sasaki as the winning design firm. Next steps will be to work with Sasaki on a master plan. The initial phase of work coincides with the John Nolen Drive causeway work. On June 15 - 16 Sasaki staff will be in Madison. They plan to meet with Ho Chunk, Clean Lakes Alliance, Monona Terrace staff, and they may get a tour of the building. The Monona Terrace Board needs to make a decision regarding accepting an expansion. This will be on the agenda in June.

Event revenue is projected to be 7.4% above budget, at \$3.87M vs \$3.6M, and total revenue is projected 6.3% above budget at \$4.1M vs \$3.9M.

If all of the conferences book then Conferences and Conventions will total 49 for the year. As a comparison, 2019 held 60 conferences and conventions. It's not at prepandemic levels yet, but overall the year is shaping up well.

April was a good month for Monona Terrace. There were 3 conventions rather than only the two budgeted. This definitely contributed to additional revenue. Additionally, expenses were down, which really helped shore up the year-to-date surplus of \$189,000.

The Future Planning workshop on May 4 went well. The mayor attended along with some board members. The data should be ready to share with the board at June's meeting.

The parking ramp project is slowly moving forward, they had some hold-ups including weather and issues with the size of plating. Staff has regular meetings with the State and the construction contractors to address issues.

The rooftop is fountain up and running. Staff is doing preliminary work on upcoming renovation projects. The bidding process has been slower than normal; however, the work is on track.

Staffing remains a challenge. There has been some turn over, primarily in part-time positions. Several of the second and third shift staff are interested in finding first shift jobs. Of course when possible, internal promotions are used to fill openings. That has left the hourly/part time pool diminished. A new full time facility maintenance worker with a painting background has been hired. Positions have been offered to 2 people for hourly security; the goal is to have 4 security positions filled.

Meetings between the newly elected alders and the director continue. The alders seem generally supportive of Monona Terrace, but do not know the roll of the room tax commission, transient occupancy tax or Monona Terrace's economic impact and funding.

Lake Vista opened on May 16. Monona Catering is still hiring.
