3. **DISCUSSION ITEM: Discuss and evaluate Ordinance and Regulations language pertaining to uniformity in all street vending categories having seniority status based on their first day licensed. Two documents drafted by Assistant City Attorney Lara Mainella, with the following titles, will be discussed:**

A. An ordinance amending sections 9.13 (6)(n)4.b and 9.13(10)(g)2. of the Madison General Ordinances to revise the method of determining vendors' seniority.

B. A resolution authorizing amendments to the "Regulations Governing Vending on the State Street Mall/Capitol Concourse" and "Regulations Governing Vending in High Density Vending Areas" to require consecutive years of licensed vending in determining seniority for certain types of vending licenses and site assignment procedures.

4. **DISCUSSION ITEM: Discuss and evaluate language pertaining to the revocation of an individual street vendor license and/or a related vending business license; whether a vending license may be revoked for a period exceeding one year.**
5. **DISCUSSION ITEM: Discuss and evaluate language requiring vendors to set up their displays on paved surfaces and any exceptions.**
6. **DISCUSSION ITEM: Discuss and evaluate language pertaining to a system of waiting lists in vending categories.**
7. **DISCUSSION ITEM: Discuss and evaluate language pertaining to the consistency of Mall/Concourse food cart menu signage and the requirement that all menu items be included on such signage and that all items be included during the annual food cart review.**
8. **DISCUSSION ITEM: The Southeast Campus Vending Area - Past, Present and Future**
