The CDBG Committee welcomes verbal or written statements from Madison residents or groups concerning emerging community needs and opportunities, and suggested funding priorities and terms for 2015-2016. These specific goals, objectives and terms of funding being developed will be within the overall context of the Five Year Community Development Consolidated Plan.

The Committee particularly invites comments that address these concerns:

1. As the City revises its 2015-2016 Program Funding Goals and Objectives, where should the CDBG Committee place its priorities for new funding? Which population groups? Which geographical areas? Which priorities and strategies? What types of activities?
2. How can the CDBG Committee and the Community Development Division best improve their effectiveness in working with community groups to achieve the adopted goals proposed in the 2015-2016 Goals and Objectives Statement? Are there specific opportunities or concerns emerging in the next several years that you feel the City should be addressing through its community and neighborhood development program?

Time at a public hearing is usually short, and the Committee requests that you keep within a three minute presentation limit. If you have multiple presenters representing the same agency, please try to limit presenters to three people per agency, with each having 3 minutes to speak.
