29. Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Olbrich Boat Launch Dredging - 2008, Contract No. 6250. (6th & 15th ADs)

Maintenance dredging at the Olbrich Park Boat Launch as needed over a 10-year timeframe.

Located on the north shore of Lake Monona, the Olbrich Park boat launch is one of two large launch sites on Lake Monona (the other being in Olin Turville Park on the south side), serving Madison's ever growing boating population. Its sheltered north shore location makes it a popular launch site when spring and fall winds are out of the north or northwest.

Periodically, organic and mineral sediments from both Starkweather Creek and Lake

Monona are deposited inside the breakwater where the stream current is blocked by incoming waves. This inhibits boaters from accessing Lake Monona from the boat launch. We typically find out this access is blocked soon after ice is off the lake. With the opening weekend of fishing season in early May, this does not give us enough time to apply for a dredging permit and clear the channel in time for this popular weekend.

The ten-year maintenance dredging permit will make it much easier to respond to the very vocal fishing community that uses this important launch site. As a part of the initial dredging, we will be cleaning out the breakwater opening, which should improve circulation around the breakwater and reduce future sedimentation.

Estimated cost of this project is \$90,000.00.
