As indicated, I have worked for the State of Wisconsin's Department of Health Services managing a large and complex Medicaid program serving people with disabilities. In this position, I managed over \$400 million dollars, worked with all seventy two Wisconsin counties and some of Wisconsin's Indian tribes.
