Staff Findings: The preservation file for this property states it is a Colonial Revival two-story brick veneer building altered by architect Ed Tough in 1937 as a residence for Katherine P. Regan, original date of construction unknown. The file also shows that the Landmarks Commission reviewed this property on the demolition agenda in 2017 and again on June 4, 2018. At that time, by unanimous consent, the Landmarks Commission voted to recommend to the Plan Commission that the building had historic value related to the vernacular context of Madison's built environment, but it was not itself historically, architecturally, or culturally significant. The site file with the Wisconsin Historical Society states similar information.
