OFFICER NARRATIVE:

On 1/14/10 I was contacted by Lt. McCaw in regard to an apparently derelict food vending cart on Library Mall. The cart in question is lettered "Jin's Chicken" and had been sitting unattended for the past one to two weeks outside Memorial Library. Lt. McCaw advised the complaint was coming from a citizen through Warren Hanson, City of Madison Mall Vending Coordinator. He asked that I check to see if the cart was still parked on the mall and whether we would be justified in towing it.

It should be noted I was able to confirm the citizen complaint since I patrol the State Street/Library Mall corridor on a daily basis. Upon arrival at Library Mall, I found the Jin's Chicken cart sitting in the same location reported by the citizen. What proved to be an empty propane tank was sitting upright between the forks of the trailer hitch. The cart itself was rusty and run down in appearance, and in my admittedly subjective opinion constituted an eyesore. When I looked inside the cart, I observed cooked but uneaten chicken rotting in one of the deep fryer baskets, raising immediate health concerns on my part.

A mall maintenance lead worker who identified herself as Laura Bauer stopped by my location while I was inspecting the cart. She informed me that to the best of her knowledge, the cart had been sitting in the exact same location since at least the first of the year. I made telephone contact with both Warren Hanson and Assistant City Attorney Lara Mainella. The consensus that emerged from our discussion was that the cart had been abandoned and warranted removal from the mall.

Mr. Hanson provided me with the particulars on cart owner Jeffrey Okafo, and I used these to complete a City Ordinance citation in his name. Assistant City Attorney Mainella provided me with the appropriate ordinance numbers for the violation. She cited specifically Section 4L of the city vending ordinance, which prohibits storage of vending equipment without the vendor present on City of

Madison property. Schmidt's wrecker responded to the mall at my request and towed the cart to their secure storage facility. Okafo has been mailed his copy of the citation. Please note that in running a routine CIB query on Okafo, I learned Jefferson County Sheriff's office had issued a warrant for his arrest the same day. Okafo failed to make a court appearance on an unrelated charge.
