Radelet explained the ways in which individuals get on the interested list for housing. Radelet mentioned the Commission may think of holding some sort of session to inform builders and realtors about potential building issues for people with disabilities. There was also a discussion about if and how Movin' Out recieved feedback from their tenants about adaptations and changes for accessibility.
