We, the undersigned, being an owner of property benefited by the following proposed public improvement to be made by the CITY OF MADISON, of Dane County, Wisconsin, to-wit: Design and construction of a regional stormwater management system, detention facilities, and appurtenant stormwater management facilities in consideration of the construction of said improvements by the City of Madison agree as follows:

- 1) That the property will benefit by the design and construction of a regional stormwater detention facility and appurtenant stormwater management facilities.
- 2) In accordance with Section 66.0703(7)(b) of the Wisconsin Statutes, we hereby waive all special assessment notices and hearings required for special assessments.

- 3) The City of Madison shall have the right annually during the payment period above specified, to place an amount equal to one-eighth (1/8) of said charge above specified, together with interest on all unpaid balances thereof at the prevailing interest rate of six percent (6%) on the tax roll to be collected together with the general taxes in the same manner as if said charge had been levied as a special assessment against the property and as if the said annual amounts were installments of said special assessment.


- 4) In the event of a default in the payment of any of the said eight (8) annual installments above specified, the collection of the same may be enforced by the City of Madison either by an action for debt, or by sale of the property for nonpayment of taxes.




