WPS Rate Case Outcomes

Fixed charges - residential/small business classes 2015-2016

Proposal (Rg-1) – (\$10.30 \rightarrow \$25)

Proposal (Cg-1) – (\$12.50 \rightarrow \$35)

- \checkmark Ruling (Rg-1) \rightarrow \$19/mo.
- \checkmark Ruling (Cg-1) \rightarrow \$25/mo. (single phase)

Meanwhile in Michigan,

On October 17*, WPS filed an application with the Michigan PSC to increase residential base charges on its 9,000+ U.P. customers (from \$9.00 to \$12.00) and increase the energy rate (see next slide).

We Energies Rate Case Outcomes WE comes close to running the table

Residential/small business classes -2015

- ✓ Higher fixed charge (\$9.13 \rightarrow \$16/mo.)
- ✓ Lower energy rate (13.9 \rightarrow 13.5 cents/kWh)

We Energies Rate Case Outcomes

Solar Customer-Generators – 2016 (residential/small business classes)

- ✓ New capacity demand charge (\$3.80/kW/mo.)
- \checkmark Higher 2nd meter fee (\$1.40 \rightarrow \$3.40/mo.)
- ✓ Monthly netting instead of annual netting
- √ 10-year exemption for certain existing solar owners (installations after 10/1/2014 not covered)
- X Prohibiting leased generation arrangements (current legal ambiguity continues)

MV observations/predictions

- ✓ Solar industry will file legal challenges to WEPCO's solar rate changes, especially the capacity demand charge (a/k/a "tax")
- ✓ Solar rate changes will have little impact on WE's C&I customers
- ✓ We Energies poisoned the well for solar was denied cost recovery for its proposed 7.5 MW, \$25 million solar project.
- ✓ If the utilities want to go up to \$25/month in their next rate cases, the PSC will approve that request

Outlook for MGE

PSC approval of MGE's proposed rate redesign for residential customers (monthly base charge - \$10.40 → \$19.00 -- per kWh energy rate 14.4 → 13.3 cents) a foregone conclusion.

PSC could make changes to MGE's proposal to create new net metering classes for existing customers (e.g., reduce duration from 15 years to 10 years)
