

## Summary of Licenses Granted and Issued

The City of Madison has a quota of 463 Class B Combination Liquor & Beer licenses under state law. There are 71 Class B Combination Liquor & Beer licenses available under this quota. The city has issued 74 of its 139 Reserve licenses and 325 of its 325 Grandfathered licenses. The city has issued 125 Class A Beer, 84 Class A Liquor, 103 Class B Beer, 399 Class B combination, 1 Class B Liquor (Winery), 83 Class C Wine, and 26 Class A Cider licenses.
