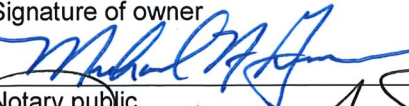

3. The following alternatives and supporting information are proposed as a means of providing an equivalent degree of health, safety and welfare as addressed by the rule:

Based on initial physical reviews of classroom security and input from students, faculty and staff, our Emergency Management Task Force (comprised of representatives from all areas of Campus) has conducted a threat assessment of our buildings including an inventory of all doors and existing locking hardware. Prompted by the results of this extensive project, we have equipped key areas of our campus (classrooms, auditoriums and conference rooms) with Nightlock emergency lockdown technology for use in the rare event of a lockdown due to an active shooter or similar threat to life safety.

While buildings where this technology is available are fire sprinkler protected, many of the classrooms equipped with Nightlock devices are otherwise unable to be physically secured from the inside by occupants.

Edgewood College lockdown practices and associated training utilizes the "Run-Hide-Fight" model, in which the campus community is instructed to flee a shooter situation if at all possible and utilize room locking only if escape is not possible due to proximity to the shooter. Mass notification of emergency events is accomplished via text, email, RSS, campus television, social media and PA systems. As a supplement to our Campus lockdown process, a simple training document is used to familiarize all users in how to deploy these devices. Training and hands-on demonstration are conducted for all faculty, staff and students at initial orientation and the beginning of each semester. The Security Department coordinates drills.

Each device is stored in a translucent box mounted inside applicable rooms on a wall adjacent to the door, accessible to all faculty, staff and students. These locking devices are also able to be deployed by persons with disabilities and limited strength, an important distinction over the national best practice of barricading doors with large items and furniture essentially making egress impossible. Most of our rooms only contain lighter items.

In the instance that a Nightlock device is deployed for reasons other than life safety, it can easily be removed from outside a locked room using a simple tool in the custody of our 24/7 security staff. Additional removal devices are housed in key offices to include Health and Safety, Campus Assistance Center and Facilities Services.

The Madison Fire Department supports this variance with the following conditions:

1. The Nightlock barricade devices may only be used in building protected throughout with fire sprinklers.
2. This variance shall apply to the Nightlock device only. The use of any other barricade devices requires separate review.
3. This variance applies to classrooms and rooms with a capacity of less than 100 persons.
4. Documentation of staff training and drills shall be submitted to the MFD annually.
5. A lockdown plan in accordance with section 404.2.3 of the IFC shall be submitted to the MFD within 30-days.

Faculty, Staff and Students –

We have added an enhancement to our campus safety and security program for the beginning of the fall semester. Many of you may have already noticed a Nightlock Lockdown device near the doors inside some of our classrooms and conference rooms.

This very simple device enhances your ability to secure a room regardless of existing locks.

In the event that its use is necessary, simply remove the red Nightlock device from the wall box (Image 1), insert it into the door slot, and slide it down into the floor plate (Image 2).

- Keep it Safe and Available

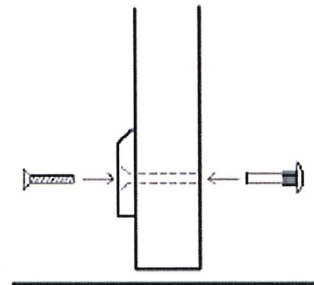
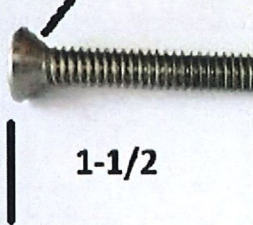
The NIGHTLOCK Lockdown's connecting handle can be conveniently stored in a secure location in the classroom by the teacher. A handy holder is provided with each unit and can be positioned anywhere in the classroom for quick access to the handle incase of a Lockdown Event. The handle is RED for easy visual locating. Most schools prefer positioning on the wall near the door, or at the teacher's desk.

The Door Plate Screws

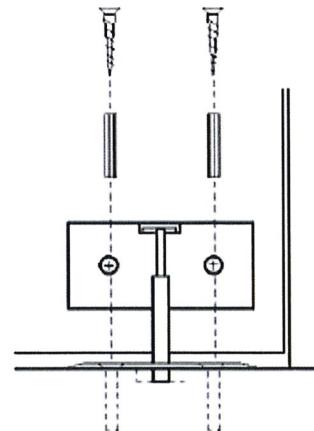
Phillips Flat Head 1/4-20 X 1-1/2"



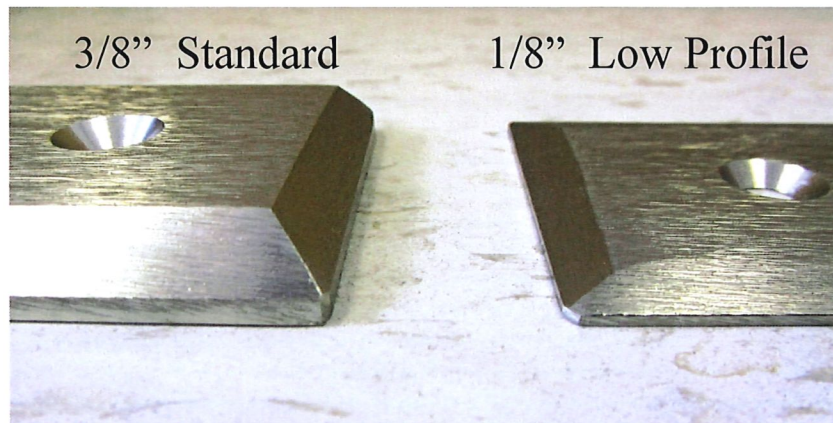
The Door screws are actually Binding Post Architect Bolts. They go all the way thru the door and bolt into a tamper resistant rounded head binding nut. They are ADJUSTABLE to fit doors 1-3/8" to 2-1/4" thick.

The Floor Plate Screws are 2" long and come with cement anchors for installing on tile and cement floors.

All fastening hardware is included with locks.



Floor Plate Options



The 1/8" thick Low Profile floor plate option requires 1 extra step during installation.
A shallow recessed hole in the floor, below the center hole, only 3/8" inch deep.
Easy to do, see the Center Hole Tip Sheet .



Both options are the same price and have the same strength rating.

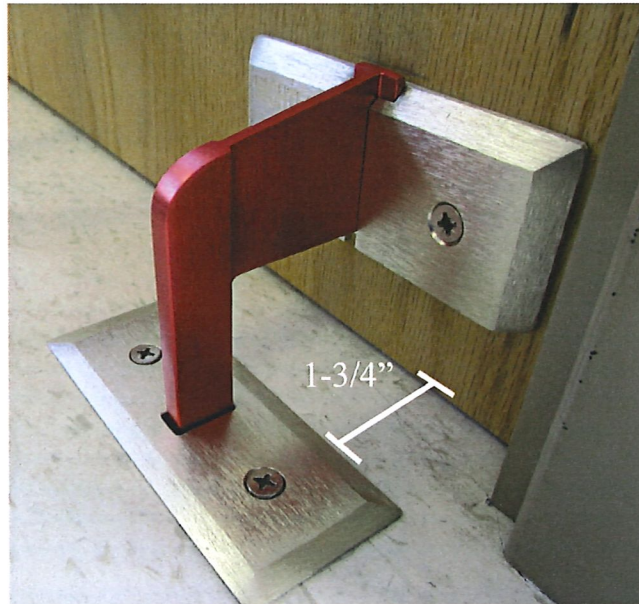

RELEASE TOOL

The Release Tool is for (police, fire and administrative use only) to unlock and release the Nightlock device from outside the saferoom.

You should have one available in each building.

We recommend having the Release Tool kept in a secure location such as the school's administrators office.

1 Release Tool for each building is included FREE with your lock order.

When ordering Nightlock devices, let us know how many buildings you have.



The release tool simply slides under the door from the outside. Then lift handle.
