Notes on proposed changes to licensed premises:

For the past two years the Madison Night Market has brought in thousands of people to the Gilman Street area to enjoy a night out in an often underused and underappreciated area of Madison's downtown. Samba has been able to host the Biergarten for the Night Market and is planning on doing so again in 2019. The details for our Biergarten operation are:

- Proposed changes only in effect on the following dates and times of the Madison Night Market:
 - Thursday, May 9 2019 from 6pm − 1gpm iô ρm
 - o Thursday, June 13 2019 from 6pm − 11pm (0 M)
 - o Thursday, August 8 2019 from 6pm 11pm 10 / m
 - O Thursday, September 12 2019 from 6pm 11pm
- Parking lot space provides approximately 4,800 usable square feet of space with requested capacity of 384 persons
 - Parking lot area is approximately 60 wide by 120 feet deep (7,200 sq ft). Proposed usable area covers 60ft lot width times 80ft depth (4,800 sq ft), with a requested capacity of 384 persons, allowing 12.5 sq ft per person as some tables and chairs will be provided.
- Proposed space has existing steel fence surrounding the perimeter of the parking lot area and
 one section of crowd control fencing is installed to provide a checkpoint for staff to check IDs
 and to count patrons entering and exiting the Biergarten. This provides two paths, 10 feet wide,
 on either side of the fence to allow for ample emergency exit space.
- All attendees will enter and exit through a checkpoint at the base of the parking lot adjacent to Gilman Street.
 - Staff will be on hand to check IDs, hand stamp all attendees, and control capacity.
 - Signs will be posted at entrance ("Alcohol Permitted Within Gated Area Only") and exit ("No Alcohol Beyond This Point") and Staff will direct attendees to dispose of any containers before exiting the designated area.
- The only alcohol to be served to attendees will be beer served from a temporary mobile trailer.
- Will cease sale of alcohol at 10pm to allow ample time for the space to be cleared prior to the 11pm closing time of the Madison Night Market.
- · Additional decorative lighting will be installed and used during the event hours
- A 30ft x 20ft tent will be installed on the Eastern corner of the lot to provide shelter for attendees in case of rain and to provide shade if weather cooperates.
- Tables and chairs will be set up along the North East fence line and under the large tent.
- A 10ft x 10ft tent will be installed either on the Southern corner of the lot (show in site plan) or in front of the Beer Trailer to provide shelter for staff.
