Tavern Premise - First floor, three rooms and patio (4356 square feet), outside deck (900 square feet), basement two coolers and four rooms (3500 square feet).

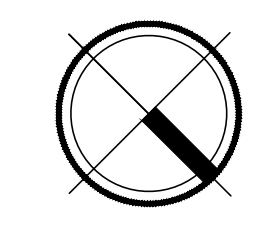

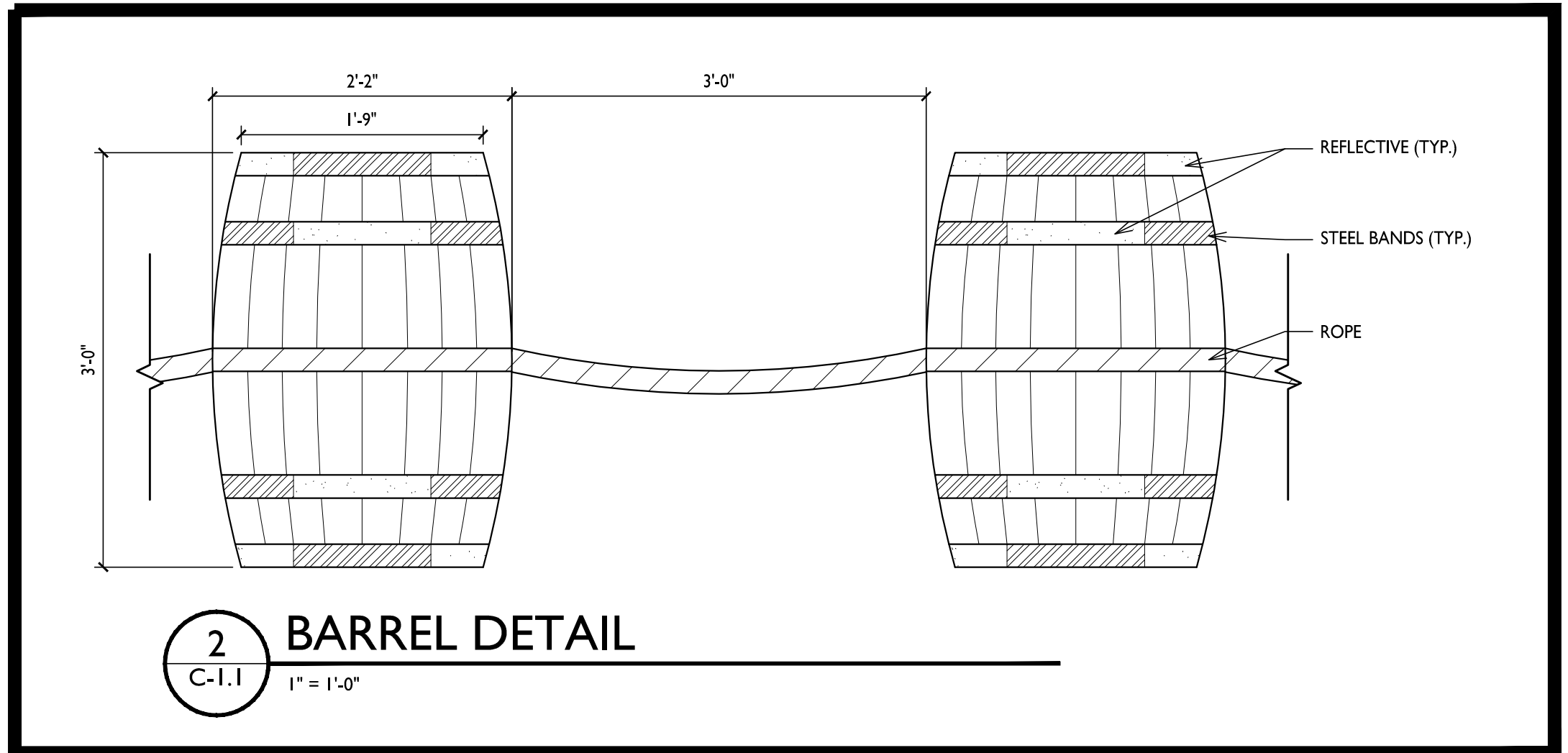
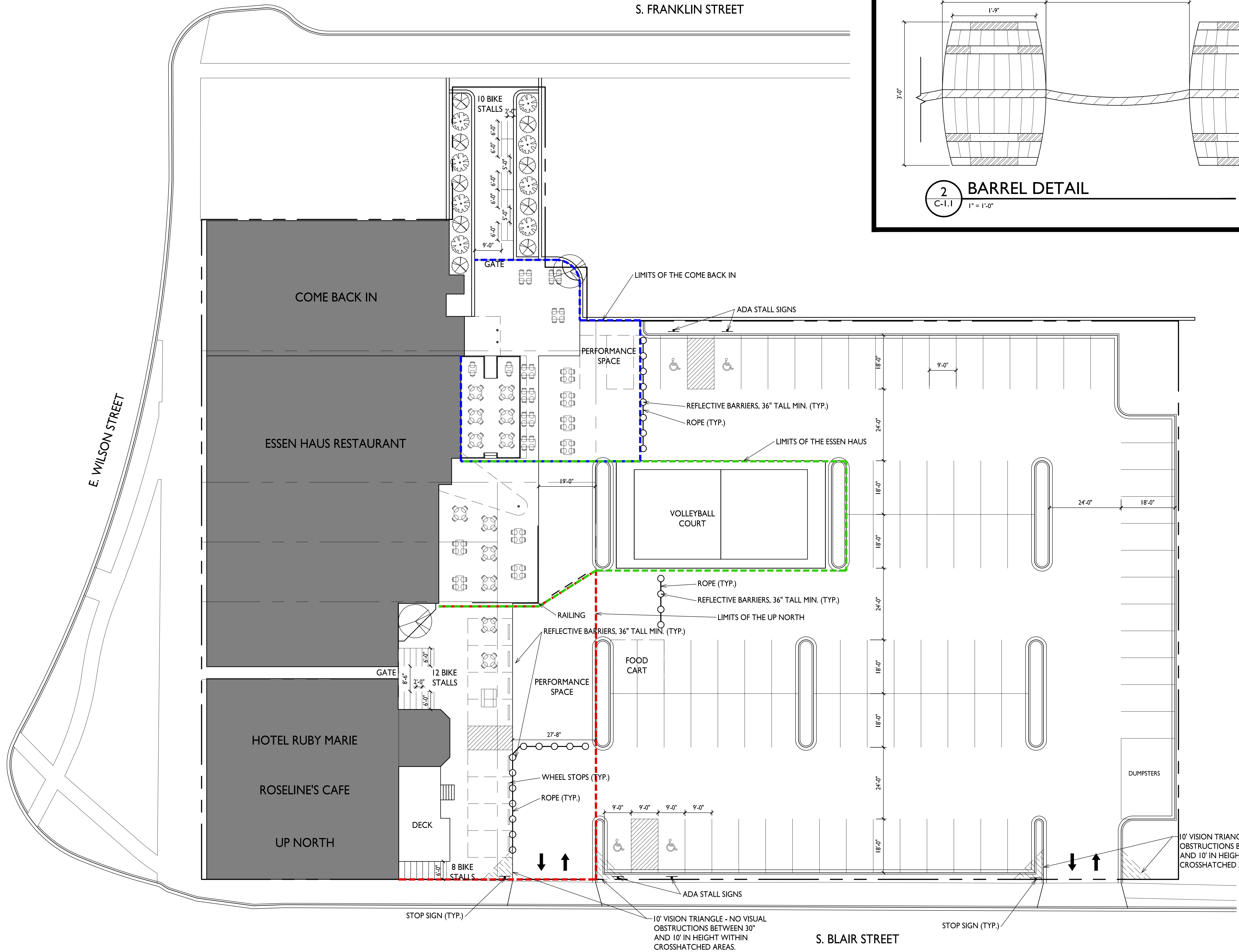
