Madison Police Department Captain Gloede addressed the committee. He indicated that the building has three addresses and most of the disturbances tend to be at the Martin Luther King, Jr. doors.

County Clerk McDonell addressed the committee, indicating that there is a need for the building to be locked down at night and that the women's bathroom on the first floor is unusable.

John Bauman, Juvenile Court Administrator, addressed the committee indicating the key question is how to get people visiting youth in detention into the building safely.

Brenda Konkel addressed the committee, indicating there needs to be a place of people's belongings, that there is a need for a wet shelter, and expressing support for a homeless court.
