## SECURITY PLAN

The Fountain offers various jazz artists, acoustic as well as amplified; Irish music; an employee lead funk band; blue grass performances, etc. Most nights of the week, dinner music is played on one of the two pianos; and several evening of the week we play Hammond Organ music. We also have poetry readings and meetings of various kinds. We have occasional dj events with dancing, and birthday and other parties.

Regarding security, we will have a person at the door Thursday through Saturday to enforce the capacity of the premises, check ID's and maintain order. This will be in addition to the bartender staff on duty.

The premise does not have a parking lot. We will stop alcohol service one half hour before closing the restaurant. For the entrance line, security will identify any intoxicated or unruly patrons and deny them entrance. Patrons with false IDs will have the ID confiscated and not permitted entrance. For larger events or parties, those of age to drink alcohol will be identified by a hand stamp.

Security personnel will call the police whenever a disturbance results in physical contact, illegal activity or threats of violence.

We have a daily cleaner service that maintains the cleanliness of the premises.
