- 1. add language to new 38.05(9)(e)2. requesting that the city clerk notify the street use staff commission administrator when the council approves or denies a temporary class B license for a street use event and what the conditions are (if any.)
- 2. clean-up items needed to the street use ordinance: 10.056(o)(6) Increase the fire lane width requirement from 16' to 20' (request of fire dept.)
- 10.056(8)(a), (b), (c) changes to the maximum limit for certificates of insurance when required for events from \$1 million to "as determined by risk manager." 
  · make the indemnification requirement for street use applicants apply to all events.
