## BUCKINGHAMS SECURITY PLAN 2017

### 1. TYPE OF LIVE ENTERTAINMENT

#### a. HOSTED KARAOKE

- i. SECURITY: 3 STAFF MEMBERS ON SITE, LOCATION OF ONE AT EACH ENTRANCE/EXIT (2), AND A 3<sup>RD</sup> WHICH WALKS THE CROWD ON A CONSISTENT BASIS, MONITORING CROWD AND CAPACITY, COMMUNICATING CAPACITY TO THE ENTRANCE AND EXIT SECURITY STAFF UNTIL CAPACITY IS REACHED.

### 2. HANDLING ISSUES OF

#### a. PARKING / PARKING LOT ISSUES OPERATIONAL HOURS AND AT CLOSING

#### b. ENTRANCE AND EXIT LINES MANAGED AND CONTROLLED

- i. REAR ENTRANCE DOORS ARE USED AS "EXIT ONLY" AFTER 10 PM OR WHEN REACHING CAPACITY, WHICHEVER COMES FIRST
- ii. ENTRANCE AND EXIT STAFF WILL ASSURE EACH CUSTOMER HAS ID AND IS OF LEGAL DRINKING AGE TO ENTER. THOSE WHO ARE NOT OF AGE OR SEEM DO NOT HAVE APPROPRIATE VALID ID, WILL BE NOT BE ALLOWED TO ENTER.
- iii. (IF FALSE IDS ARE TO BE CONFISCATED WE WILL DO SO, AND HAND THEM INTO THE POLICE DEPARTMENT IN A TIMELY MANNER)

#### c. PATRON ISSUES

- i. ID HANDLING
- ii. THOSE WHO ARE NOT OF AGE OR SEEM DO NOT HAVE APPROPRIATE VALID ID, WILL BE NOT BE ALLOWED TO ENTER.
  1. (IF FALSE IDS ARE TO BE CONFISCATED WE WILL DO SO, AND HAND THEM INTO THE POLICE DEPARTMENT IN A TIMELY MANNER)
- iii. UN RULY AND INTOXICATED CUSTOMERS
  1. UNRULY CUSTOMERS WILL NO LONGER BE SERVED AND WILL BE ASKED TO LEAVE THE PREMISES
  2. INTOXICATED CUSTOMERS WILL NO LONGER BE SERVED, GIVEN WATER TO DRINK AND OFFERED SAFE RIDERS AS NECESSARY
- iv. UNDER 21 PATRON MANAGEMENT-THEY WILL NOT BE ALLOWED TO ENTER!
- v. CIRCUMSTANCES ON WHICH POLICE WILL BE CALLED
  1. WE WILL EXERCISE THE "UNRULY CUSTOMER ORDINACE" WHEN OUR PARTON HANDLING PROCEDURES ARE UN SUCCESSFUL, AND CONTACT THE NON-EMERGENCY POLICE NUMBER
- vi. HOW WILL PHYSICAL DISTURBANCES AND/OR FIGHTS BE HANDLED
  1. WE WILL INSTRUCT OUR SECURITY STAFF TO SEPARATE PARTICIPANTS FROM EACH OTHER & THE CROWD. WE WILL KEEP THEM SEPARATED AND DETERMINE WHO NEEDS TO BE REMOVED FROM THE PREMISES.
  2. IN THE CASE OF A LARGER DISTURBANCE, OUR STAFF WILL KEEP THE REST OF THE CROWD SEPARATED FROM THE DISTURBANCE, AND IMMEDIATELY CALL FOR POLICE ASSISTANCE.
