The proposed geometry includes a new single lane roundabout at the intersection of High Point Rd. and Raymond Rd. and extends High Point Rd. to match into the cross section being constructed as part of the ongoing development in the area. The southerly, westerly, and easterly legs will be constructed and extended as necessary to connect the new roundabout into the existing streets. Sidewalks and paths are proposed as necessary to either connect into existing facilities, connect into other planned facilities, and as necessary to provide access for all modes through the new intersection. Geometrics were previously approved by the Transportation Commission on 9/10/25.

This agreement would allow the City to negotiate directly with Waste Management for disposal of solid waste material that may be encountered on future City projects within the allowed timeframe. When found on projects, contaminated materials must be disposed of in a DNR-licensed landfill, leaving few options available – either Waste Management Landfills at Madison Prairie or Deer Track Park or the Dane County Rodefeld Landfill. Fees for disposal of this type of material are considerably less expensive at the Waste Management landfills as compared to Dane Co.

The Fordem Ave. – First Street Relief Sewer project is to replace a 12" cast iron sewer installed in 1946 under the railroad tracks at 1894 E Johnson St. This property is owned by the WisDOT and Canadian Pacific. The current main has a segment that is back pitched and limited available capacity. The project at 1601-1917 Sherman Ave. has increased the demand on our sanitary system and our project end date is to coordinate with the occupancy of that private development project. The estimated cost of the project is \$901,000.
