This letter is written in support of Tim Johnson's request for some flexibility in requiring him to meet the obligations associated with his participation in the NOAH Program.

When a neighborhood reaches a tipping point, the response seems to be adding police officers, demanding more resources from the city, and getting the residents involved. The latter is often the most difficult to accomplish. Tim Johnson stepped up early to offer me (as his alderperson) and the neighborhood his assistance. His tireless efforts have improved the neighborhood's lines of communication, thereby energizing the community. He created a landlord compact for Russett Road, started a Meadowood neighborhood email group, single handedly attended to the neighborhood's crime issues, and created a simple form for residents to report criminal acts. In addition, he serves on the Meadowood Association Board, and his attendance at so many other neighborhood meetings makes him a key player in improving District 20.

If the object of the NOAH program is to put someone stable in the neighborhood to improve its condition and help low income people find decent, affordable housing, then Tim has accomplished that and much more. He is a key force in working to improve the entire southwest side of Madison. He is well known to most people who have been active in landlord/tenant relations in Meadowood. His name comes up early whenever energetic membership on a committee is needed or when someone is needed for some other project. Tim will be sorely missed when he moves from the city.

I, therefore, hope the CDBG Commission will take into consideration all Tim has accomplished in Meadowood neighborhood and in the southwest side of Madison, generally, when they consider his request.. Tim did far more than NOAH could have expected and the city should be grateful to him. I suggest the CDBG Commission negotiate a repayment from him that is more feasible for this low income landlord.
