Description of incident:

Mr. Alexander was working on the computer and began swearing loudly into his cell phone. JJ asked him to take his call outside. He swore at JJ and argued with her about getting off the computer. JJ asked him to leave for the day - he refused. She told him she would be calling 911. He still refused. He refused to respond to or leave with police. They physically removed him from the library. Once outside he continued to be disorderly with police and was arrested. PW said a patron reported that he was glad Mr. Alexander was being removed from the library because he had been insulting other patrons in the library.

After the Mr. Alexander left, we found out he had a previous 6 month and year long ban at Lakeview. Based on this he will be banned from all Madison P.L. branches for one year.
