Brian Grady, City Planner shared a presentation on the final phase of the City of Madison Imagine Madison Compreshensive Plan. He displayed a map which detailed growth and the overall plan for the city over the next 10 years. The plan is a guide with decisions that would need to be made through the Council for approval except for the generalized future land map. Joe Balles a Madison Police Department retired Captain now in a new role as the Madison Metropolitan School District School Safety and Security Coordinator shared information on the Madison Community Policing Foundation, a non-profit organization that he established. He also shared his role as the Madison School District Safety Coordinator. The Foundation provides financial support and has retired officers that assist with events and activities. As the Safety Coordinator his job is to keep approximately 27,000 children safe. He touched on different areas of involvement as the coordinator. One area is working on new legislation that requires every school to have a safety plan in place. To accomplish this there is a grant that will be used with the assistance of the Madison Police Department and the Board of Education to work on school safety items over the Summer. Another area he talked about was active shooter trainings that staff have been involved with. He spoke about Educational Resource Officers (EROs) in the schools that come together once a month to meet with the principals and each other to talk and share information from each school. Discipline and racial disparities were discussed. A few suggestions shared was training ERO's so they are consistent with students behavioral issues, school suspensions and finding positive means of making those up within the school, and with early dismissals finding positive areas for students to be involved with. The PSRC suggested to invite Mr. Balles back to a future meeting to hear about any updates or changes on safety at the schools.
