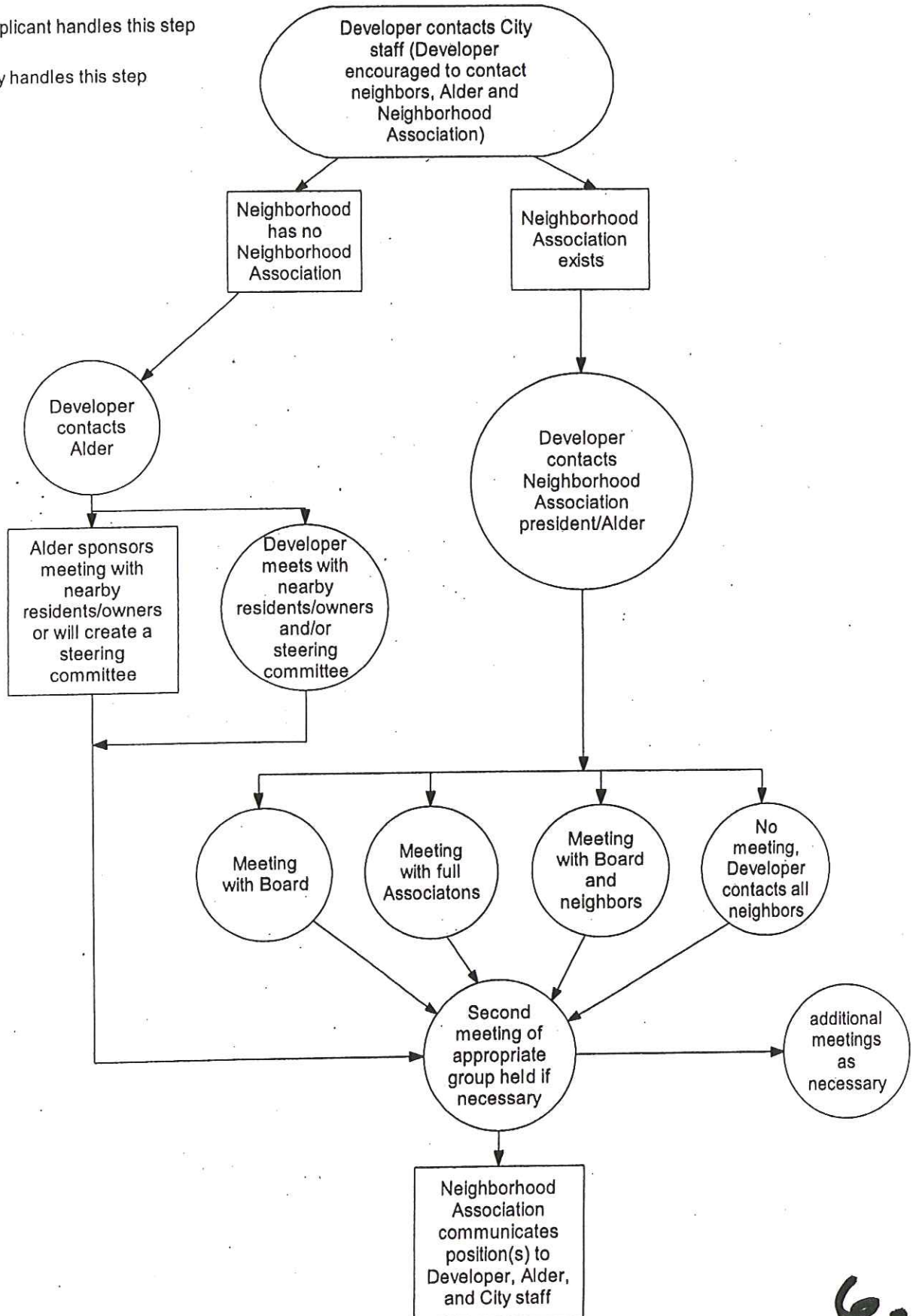


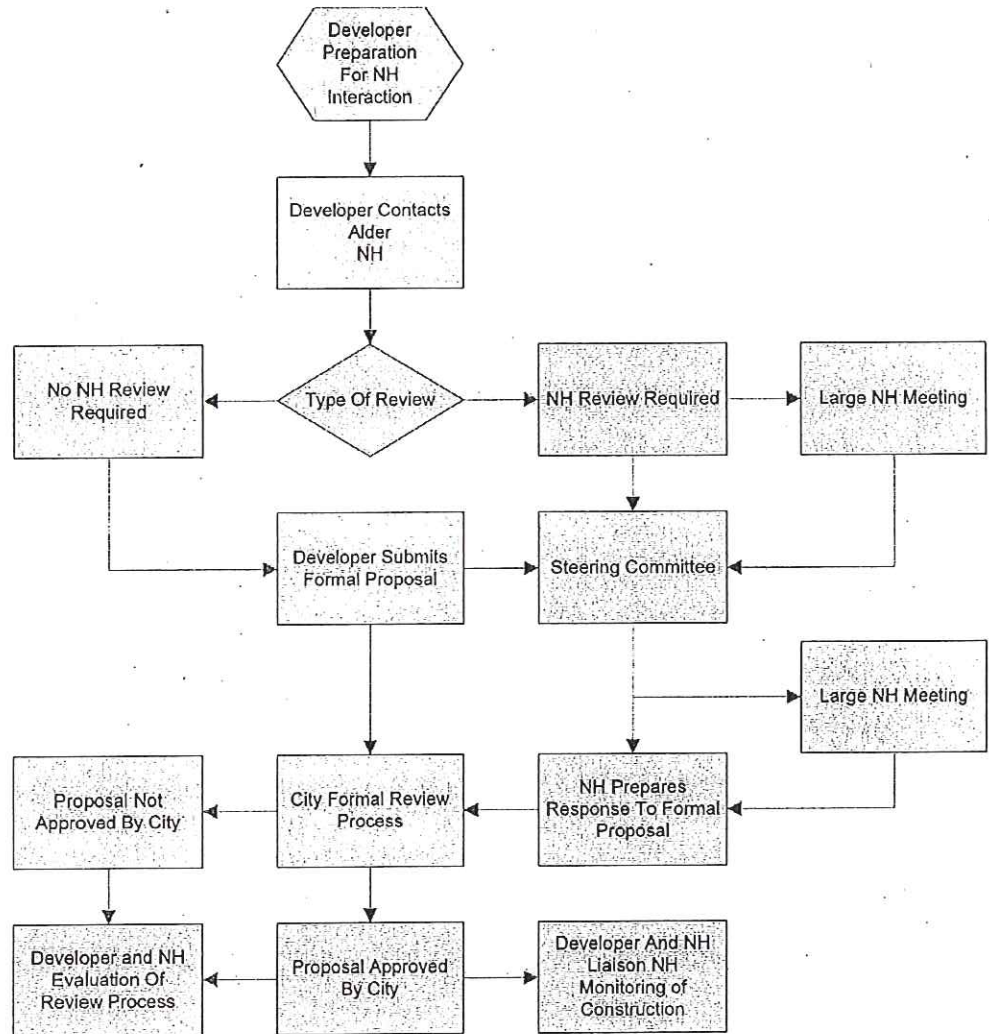
B2. Informal Neighborhood Review Process Flow Chart

Hello Judy Olson, a friend gave me your email for me to reach you and others hopefully who work on the Planning Committee. I write in regards to the plans to tear out several homes on North Butler Street, one of which was in our family in the early part of the last century but has since been owned by other parties.

But I ask of you to save the house and other homes in question as it will be the start of loosing more homes once this developer, Cliff Fischer, get the ok to do what he wants. It will be the start of other home losses. And whats worse, they are ones which currently home the low income people who sure will not be able to afford what will be build in there later. And besides, it cuts across to entire cross-way of the block between both streets, even if plans are to not take out homes on the N. Franklin side of plans. Its the issue of letting this go and then later others can try the same.

So not only are we loosing old homes, which are good if only kept up and not neglected as has been the trend, but they are part of the old residential area of downtown Madison. Oddly, these people purchase old homes in groups to then turn around with plans like this. As I told others, I just wish these same people would put as much attention and care/upkeep on the old homes as they do in getting lofty designs for big condo/apt plans.

Have these home owners keep cleanup and upkeep instead.

And I wonder just really who the local neighborhood people are that support these plans, and how they may
(underline) may be connected with the developer.

Lastly, while emailing you, I wish and ask you all to save the old yellow home at 321 N. Hamilton Street which is part of the triangle block that McBride has no care about other than the grocery store. All the rest can go and if someone wants a house, all the more the better. No effort to reduce the size of the Hamilton developement to save the old corner home, and more its way to large of a project for that corner.

I think a project as asked looks nice and could fit there but only smaller which then also would save the corner old home I mention. Plus, its the harder home to relocate due to size unlike the other smaller ones which are easily to find relocation sites. So its a added bonus for McBride to save 321 N.Ham. to rid of burden of moving it, but, it would mean to settle for a smaller condo/apt site.

Please save the homes on N.Butler and not let one house be relocated as Cliff wants, as that is just the beginning of asking for more as the one house (with the Planning Committees' approval) would just be a way for Cliff to say later one obsiticle is out of the way (removing the one home). I look forward to your reply to learn what your thoughts are of these two plans up for this Monday night, as told in today's Wis. State Journal-- page B3.

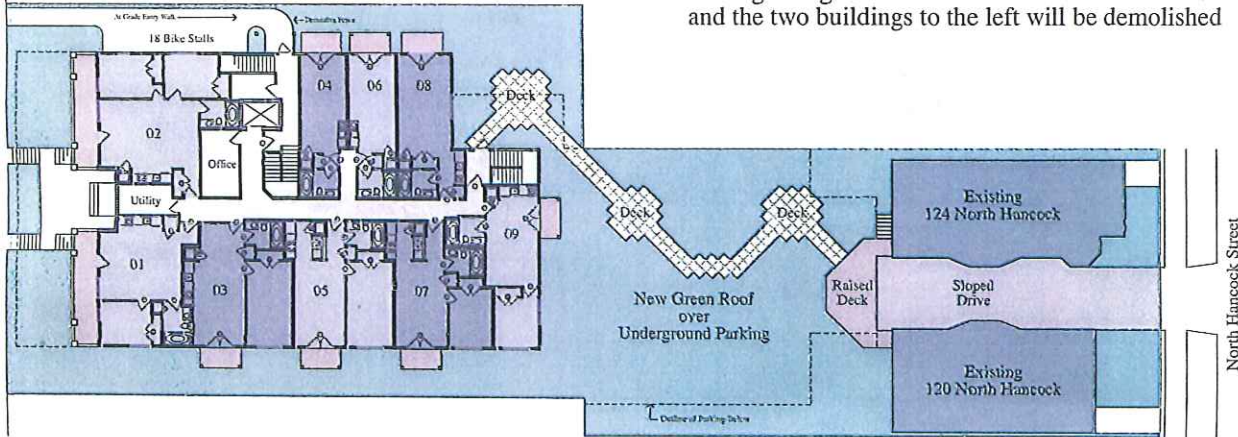

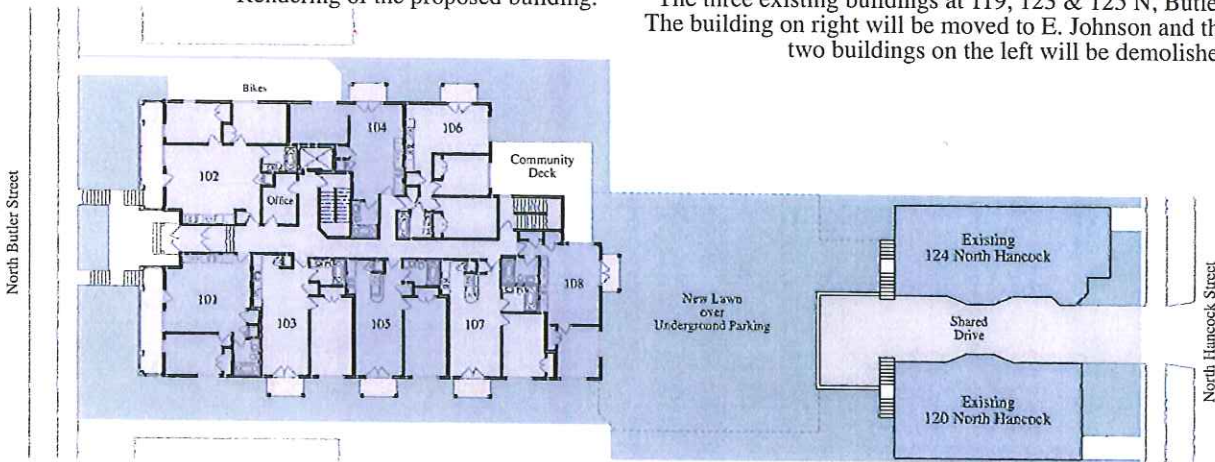
