**Project Description:** Widening a sidewalk by 3 feet on State-owned railroad right of way

**Project Location:** Prairie du Chien Subdivision of Wisconsin & Southern Railroad Co.’s Southern Division, in the vicinity of MP 139.880 near University Avenue and Breese Terrace, on the north side of Campus Drive in Madison, Wisconsin, approaching the railroad crossing.

**Terms and Conditions of Work to be Performed:**

1. Applicant may enter on the railroad corridor at the project location for the purpose of widening the sidewalk by 3 feet on the north side of Campus Drive.
2. Work is permitted with reference to existing Agreement No. 8049, executed Sep. 19, 1977, between the corridor owner and the City of Madison. This Agreement conveys rights for the City to install pedestrian crossings and sidewalks on the railroad right of way in the NW ¼ NE ¼ S.22, T.7N., R.9E., Madison, Wisconsin.
3. Applicant shall contact Wisconsin & Southern Railroad Co. at least 72 hours in advance to arrange flagging protection; contact is Ben Meighan at (414)750-6412.
4. This permit is effective until **September 30, 2010** or completion of the project.

**Indemnification:**

Applicant, **City of Madison**, shall save, defend and hold the Wisconsin Department of Transportation, the Wisconsin & Southern Railroad Co. and the Wisconsin River Rail Transit Commission and each officer, director, agent, or employee thereof harmless from and against all liability, damage, loss, claims, demands and actions of any nature whatsoever which arise out of or are connected with, or are claimed to arise out of or be connected with, any act, omission or operation of Applicant, **City of Madison**, or its agents, servants, subcontractors, employees or representatives occurring in connection with or in any way incident to or arising out of its occupancy, use, service, operation or performance of work, in connection with this Permit, its Attachments, or any amendments thereto, or which arises out of or is connected with, or is claimed to arise out of or be connected with any accident or occurrence which happens or is alleged to have happened in or about the project.

**Entire Agreement:**

This agreement and attachments hereto contain the entire agreement of the parties and supersede any and all prior agreements or oral understandings between the parties.
