Text of Legislative File 07715

No appropriation is required.

Repealing Section 2.38(2) of the Madison General Ordinances to remove the deadline requirements by which the Common Council must take action on a recommendation to confirm the appointment of a City employee.

DRAFTER'S ANALYSIS: This proposal would repeal the requirement that action by the Common Council on a recommendation to confirm an appointment must take place not less than ten business days after submission to the Council. It would also remove the provision that failure by the Council to take action on the recommendation within twenty days after submission constitutes confirmation of the appointment.

The Common Council of the City of Madison do hereby ordain as follows:

Subsection (2) of Section 2.38 entitled "Common Council Confirmation Hearing" of the Madison General Ordinances is hereby repealed.

EDITOR'S NOTE: Section 2.38(2) currently reads as follows:

"(2) Action on the recommendation to confirm shall take place not less than ten (10) business days after submission of the recommendation to the Common Council. If the Common Council does not act on the recommendation within twenty (20) days after the date of submission of the recommendation for confirmation, the appointee shall be deemed confirmed."
