#### **Project Summary**

Ultimate Arts, LLC requests approval of a Conditional Use Permit to operate a Service Business (tattoo studio) at 2017 S Stoughton Road, Madison, WI, within the IL (Industrial Limited) District. The proposed premises includes approximately 2,500 sq. ft. There will be no exterior changes to the building or site, only minor interior updates.

# Site & Compatibility

- Zoning: IL District Service Business requires a Conditional Use Permit. A Tattoo Studio is classified as a Service Business.
- Surrounding area includes other service businesses.
- Adequate on-site, shared surface parking. There are over 50 shared surface parking stalls, less than half appear to be occupied throughout a business day.
- Lease proposed to be effective 10/1/2025, or after Conditional Use approval

#### **About Ultimate Arts**

- Locally owned, continuously operating in the same location in Madison since 2001.
- Appointment-based, semi-private studio; lower traffic than salons/spas.
- Recognized as Best of Madison and Mad Faves.

- Zero health code violations in 24+ years of health department inspections.
- Owner Michael Spangler helped draft state tattooing regulations; trainer for WI health inspectors.
- Presently 5-7 full-time employees

## **Community Impact**

- Organizers of Tats for Tots, Dane County's largest toy drive (≈70–75% of Toys for Tots donations annually in Dane County).
- Consistent support for local charities (animal rescue, cancer research, homelessness assistance).
- Long-term stable staff (15+ years average tenure).
- Open office hours 11am -5pm weekdays.
- There is little to no noise impact with a tattoo studio.
- Proven record of reliability: never missed rent or utilities.
- Interior changes will include: new floor tile, washable surface wall paint, health department approved ceiling tiles. Possibly of a new hand sink based on health department guidance.
- There will be no exterior changes to the building with the exception of a sign. We will be working
  with a local manufacturer and licensed installer.

#### **Timeline & Need**

- Current lease ends December 31, 2025 (Commercial Ave property being redeveloped).
- CUP approval needed to ensure uninterrupted business and allow October move-in.
- Alder O'Brien granted waiver of 30-day notice requirement for timely submittal on August 25, 2025.
