Please see information summary that I would like to include in support of the application to remove condition #3 on Liquor License for restaurant RED, located at 316 W. Washington avenue, Madison, WI 53703

Restaurant owners: Jack Yip and Tatsiana Zhykharevich asking for permission to allow amplified music on the extended courtyard dining area that was approved in 2018. Design of the shaded structure is attached together with the application.

Detail summary:

1. New Outdoor structure for the courtyard space is approved by Madison UDC at 1.16.19 meeting
  - Features of the new structure include:
    - i. Addition of Integrated string lighting.
    - ii. Addition of integrated heaters for use in late spring and early fall.
    - iii. Addition of outdoor speaker for soft ambient music. Music to be allowed to play from 11:00 am until 10:00 pm from Monday through Sunday.
2. Seating capacity is to be remained the same.
3. Location and control of seating area / alcohol serving remained unchanged.

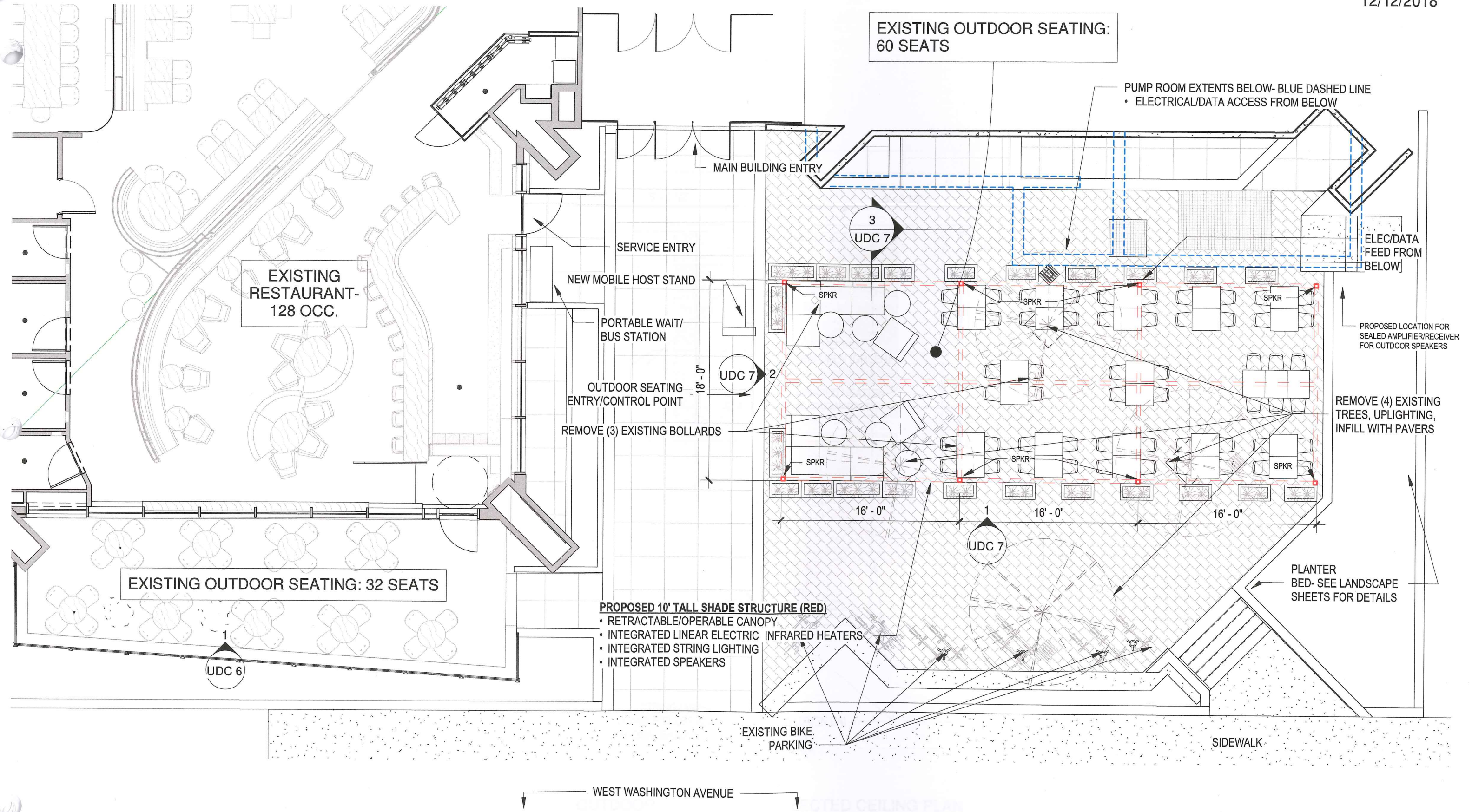

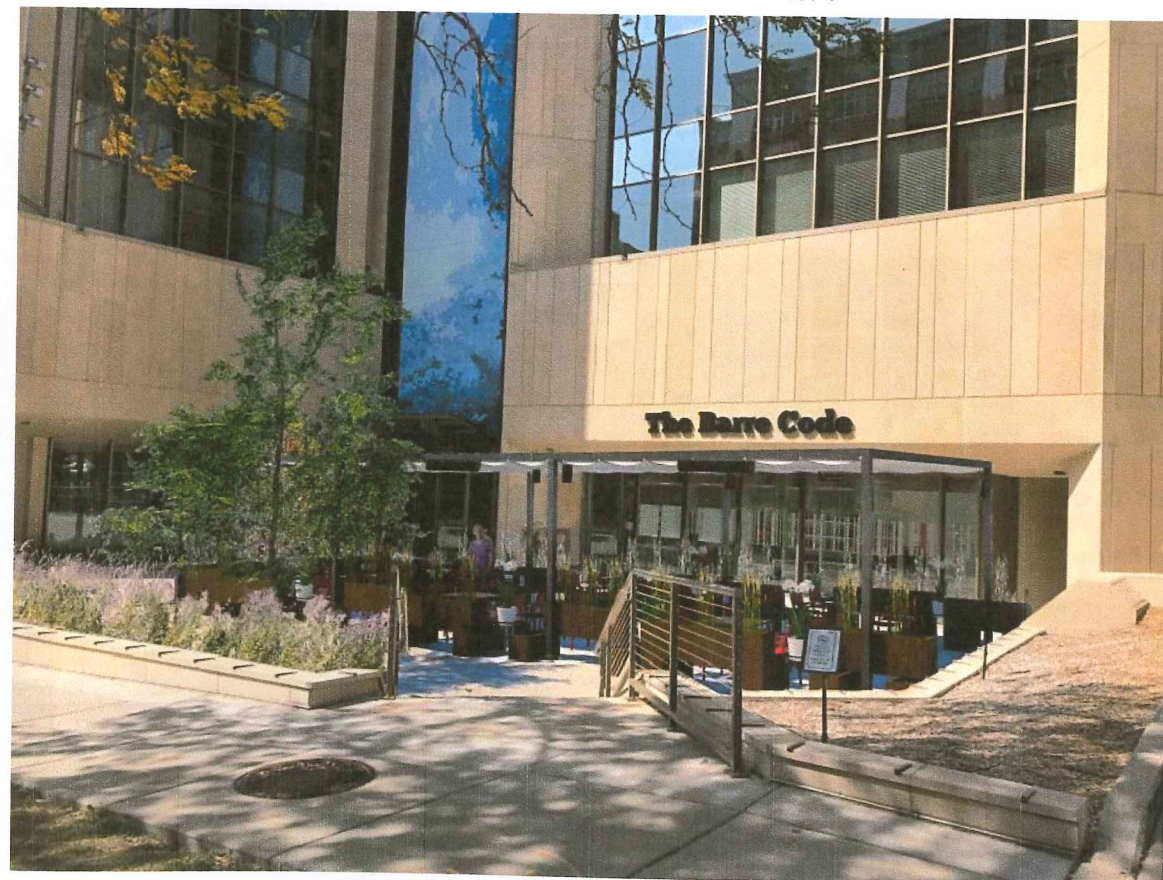
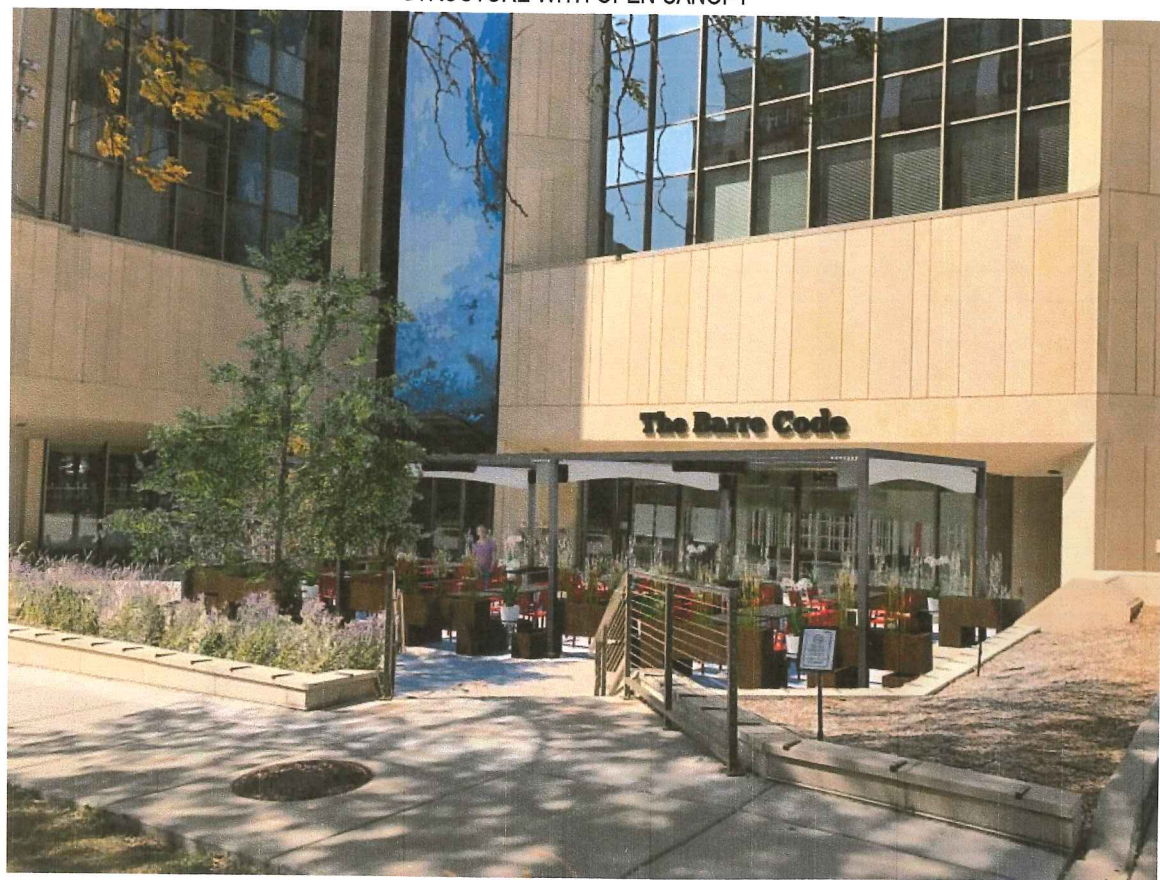
