Erdman provided the Capital Revolving Fund Update:

- ULI's revised loan request and possibly the Clark Gas Station proposal will be coming before the Subcommittee next month.
- Gromacki will be invited to the next meeting to review the Capital Revolving Fund's Policies, Objectives and Criteria which will be distributed to members prior to the meeting.
- Staff will check with the Finance Department on the question of how the timing of loan approvals and loan closings affects the preparation of the budget for the upcoming year.
- Staff will bring information to next meeting on loan balances, amortization schedule and due dates.

#### 6 19141 TRUMAN OLSON UPDATE

Marx provided the Truman Olson Update:

- Have negotiated purchase price with Federal Government.
- The Council resolution authorizing the execution of offer has been introduced.
- Funds remaining in budget after purchase should be sufficient to cover demolition.
- Public Works bidding for demolition will soon start.
- Anticipates closing this year.
- Cedar Street extension in 2014 City Budget, but could be moved up.

# 9 TIF #35 (TODD DRIVE-WEST BELTLINE) UPDATE

Erdman provided the update:

- The project includes three apartment buildings located behind the Arbor Gate

parking ramp.

- Erdman noted that no funds had been included in the 2013 budget.
- Approximately \$500,000 in the TIF District.
- Bruer had raised the idea of developing a Small Cap TIF/Work Force Housing type program for the properties.
- Brown noted that the Small Cap TIF and Work Force Housing Programs he administers both involve individual loans to borrowers wishing to purchase one- to three-unit rental properties and converting them to owner-occupied properties. Also, there is a special loan program in place for targeted properties on Lake Point Drive that focuses solely on the exterior of the buildings and site upgrade.
- Erdman suggested that we explore creating a property improvement program, focusing on both the interior and exterior of the properties.
