



The Common Council of the City of Madison, Wisconsin, having heretofore decided that it is expedient and necessary that the improvements as listed in Part II hereof be improved at the expense of the property thereby on which would be conferred some special benefit.

NOW, THEREFORE, NOTICE IS HEREBY GIVEN:

That the City Engineer has prepared plans, specifications, a proposed schedule of assessments, and an estimate of the entire costs of the improvement for each of the districts listed in Part II hereof, and;

That the plans, specifications, a proposed schedule of assessments, and an estimate of the entire cost of the improvements listed hereto are available and open to inspection by all interested persons in the office of the City Engineer, Room 115, City-County Building, 210 Martin Luther King Jr. Blvd., between the hours of 7:30 a.m. and 4:00 p.m., Monday through Friday, and will so continue to be for ten (10) working days from the first published date of this notice, and;

That on WEDNESDAY, DECEMBER 14, 2011, AT 6:30 P.M., the Board of Public Works will hold a public hearing AT THE CITY WATER UTILITY, 119 E. OLIN AVENUE ROOM A/B and will consider any objections that may be filed in writing or in person and hear all persons desiring to be heard, and;

That special assessments may be paid over an eight (8) year period year period, with the owner paying 1/8 of the principal each year plus three (3%) percent interest on the unpaid balance, as determined by the Board of Public Works.

That if the total assessment is paid in full before October 31st in the year that the billing is made, irrespective of project completion, then no interest shall be charged.

The City of Madison is proposing to reconstruct Lawrence Street, O'Sheridan Street and Bresland Court in 2012. This proposed project will include assessments to the adjacent property owners, and you are being sent this letter to notify you of a public hearing before the Board of Public Works regarding the project, at the above referenced date, time & location. City Engineering will make a short presentation at the meeting, followed by the public hearing. The project will involve special assessments to owners of property adjacent to the project. Attached to this letter is a Schedule of Assessments, which shows estimated costs for each property adjacent to the project.

The proposed limits of the project are: Lawrence Street from Lakeside Street to O'Sheridan Street, O'Sheridan Street from Lakeside Street to Lawrence Street, and Bresland Court from O'Sheridan Street to the east end. The proposed project is a complete street reconstruction including new curb and gutter, pavement, sanitary sewer, water main, storm sewer, drive aprons, and sidewalk as needed. The project is scheduled to start in the spring of 2012.

Street Improvements

The proposed street improvements include removing and replacing the existing concrete curb and gutter, asphalt pavement and base, replacement of driveway aprons, and sidewalks will also be replaced as needed to repair any unsafe or damaged sections. The City is also proposing to install new sidewalk along the north side of O'Sheridan Street (nearest to the Lake) to connect the existing sidewalks on Lawrence St. and O'Sheridan Street. Terrace walks, walks between the main sidewalk and the curb, will be removed and *not* replaced unless requested by the property owner.

Due to several large trees that have encroached on or overgrown the curb on O'Sheridan St., City Engineering is proposing to narrow O'Sheridan St. approximately 1 ft. from either side (the street would be 2 ft. narrower in total). Without narrowing the street, it would be unlikely that those large trees would survive the construction. The existing width of O'Sheridan St. is 30 ft., and the proposed minimum width of O'Sheridan St. would be 28 ft. Lawrence St. and Bresland Court would remain the same widths.

The City and the property owners adjoining the reconstruction will share the cost of the street improvements. The City shares the cost on a 50-50 basis with the property owners for removing and

replacing the curb and gutter, drive aprons and sidewalk. The adjacent property owners will be responsible for 100% of the costs of the new sidewalk on the north side of O'Sheridan St., but only for the portion of the sidewalk along their frontage. The City assumes the entire cost for the new pavement and storm sewer improvements, and also the remaining costs for the new sidewalk that is adjacent to the lake (not along a property frontage). The City also assumes the cost for curb and gutter and sidewalk ramps located at each street intersection. The attached Schedule of Assessments shows a breakdown of costs for each street reconstruction item and the total estimated cost to be assessed to each adjacent property owner. Sanitary Sewer Main and Lateral Replacement

The sanitary sewer main and laterals on Lawrence Street, O'Sheridan Street, and Bresland Court within the limits of this reconstruction project were constructed in 1928-29. The sanitary sewer main will be replaced with the project and will not be assessed to the properties. Sanitary sewer laterals are owned by the property owners and it is their responsibility to maintain them. It is the City of Madison Engineering Division's policy to pay for 75% of the cost to replace sanitary laterals within the public right of way (the length of sewer lateral between the sanitary sewer main and the property line) while the property owner is assessed the remaining 25% of that cost. The estimated property owner's share of the cost for lateral replacement within the public right of way is listed on the Schedule of Assessments. Replacement of the sanitary sewer lateral from the property line to your home is solely your responsibility and will not be coordinated or funded by the City.

It should be noted that City records indicate that some properties have multiple laterals. To determine if your property has multiple laterals, please see the column on the schedule of assessments named "Sanitary Sewer Reconnect," and that column will reflect the number of laterals indicated by the City records. It is assumed that all laterals are active at the start of a project and are listed on the schedule of assessments. However, it is possible to determine which laterals are inactive by dye testing. If it is found that a lateral is inactive, it can be removed from the assessment schedule along with corresponding charges. To avoid being assessed for unnecessary laterals, residents should contact Jill Kendall of City of Madison Engineering at 266-4087 or 266-4430 to schedule a time for city crews to dye test their property. Dye testing is done at no cost to residents and must be scheduled before January 14, 2012.

Storm Sewer

The storm sewer main, leads, and inlets will be replaced as part of this project. This work will not be assessed to the property owners. Max Conway is also the storm sewer designer for this project, and he can be contacted at the above information.

Water Main and Water Service Laterals

The water main will also be replaced with the project. The existing water main within the project limits was installed in 1927-28. The City will remove the old main that currently serves the properties and will connect all of the properties to the new water main. Property owners will not be assessed for the new water main. Please contact Pete Holmgren of the Madison Water Utility at 261-5530 or at pholmgren@cityofmadison.com with questions regarding water main.

Impact on Trees and Landscaping

Tree pruning, in advance of the project is required to reduce the risk of damage to the trees during construction. The City of Madison-Forestry section will perform the necessary work. For certain species, especially oak and elm trees, the pruning must be completed by April 1 to reduce the chance of

disease. Once the trees on the project are reviewed in more detail with the City Forestry Department, there may be trees that need to be removed prior to the project due to the tree being in poor health. Adjacent property owners will be notified of any tree removal prior to it being removed.

During construction, it will be necessary to trim tree limbs and/or roots to accommodate the construction. Tree conflicts are often encountered with sanitary sewer lateral replacements. Tree roots that have caused sidewalk to heave will be cut back to allow construction of a level sidewalk. If, during the course of construction, it is determined that a tree must be removed, City Engineering will notify property owners adjacent to the tree to be removed, prior to removal.

City Forestry Section will evaluate the terrace area for new street trees or replacements when the project is complete. Street trees are typically planted in the spring of the year following the completion of the construction project. Tree species selection is determined by the Forestry Section.

Please note that construction will also have an impact on existing flower gardens and other plantings within the terrace. With the nature of this work, property owners should anticipate that most of the terrace will be disturbed, therefore, any plantings or special landscaping features that an owner wishes to save from damage should be removed from the terrace area prior to the start of construction.

Special Assessments - General

A special assessment is a special charge for work that the City is planning to complete. The attached Schedule of Assessments shows an *estimate* of the property owners' share of the project costs based upon the City's assessment policy. After the project is bid, and work is complete, a final assessment will be calculated based on bid prices and work actually performed. The final assessment, which will be billed after the completion of the project, is payable in one lump sum or over a period of 8 years, with 3% interest charged on the unpaid balance.
