"SLIDING SCALE" Method of Compliance - Bracewell

Results of applied test of sliding scale on one previous City bid.

City Attorney opinion on applying scale to one future bid only as a test process

Bracewell presented results of test of sliding scale method of evaluation on the 2010 Fire Department bid for uniform apparel. The compliance scores for the 3 vendors are as follows: Lark Uniforms = 45% (did not meet threshold); Red, The Uniform Tailors = 64%; Schenk-Huegel = 92%.

The test did not include the evaluation of the accuracy of information submitted. What is important is that there is a signatory, even 2 levels of signature by the brand and the bidder to attest to the accuracy of the information submitted. How much weight should be given to the signature portion? Also important is to have the capacity to perform investigations; consider utilizing Sweatfree Purchasing Consortium database. Committee to consider an amendment to the ordinance for Council to delegate to the Committee, the task of establishing a policy for determining standards for compliance, e.g. if forms are being filled out correctly, etc. Committee reviewed email from Asst. City Atty. Lara Mainella about testing the sliding scale method of compliance on a live bid. (See Exhibit B – Email from Asst. City Atty.
