Hansen reviewed the member status for those present, explaining the different circumstances of voting members and non-voting Technical Assistants.

17. Discussion: Sidewalk Cafe Maintenance (Regs., page 20, XIII., B.,1.) After "sturdy and safe material.", add language referring to the maintenance of surfaces, whether painted, stained, fabric, etc.

Hansen had recommended that language be added to Ordinance 9.13 and/or the Regulations pertaining to the maintenance of sidewalk cafe surfaces. It was agreed that any such improvements would be given thirty to sixty days for completion. Schenkel requested that Hansen contact the City Attorney's Office to have suitable language drafted.

18. Discussion: Arts & Crafts Vendors May Sell Publications Completely Illustrated by Them But Written and/or Published By Others

Hansen had recommended that licensed Mall/Concourse Arts & Crafts Vendors be allowed to sell publications which they had illustrated. Schenkel asked Hansen to contact the City Attorney's Office to request that language be drafted to update the Regulations section entitled "PROVISIONS FOR SPECIFIC HANDCRAFTED GOODS" with regard to Books and Publications and possibly Paintings and Drawings. Rockwell added that he felt the illustrator should be "externally credited."

19. ADJOURNMENT

Schenkel moved and Pham-Remele seconded that the meeting be adjourned. The motion passed. Foxgrover adjourned the meeting at 5:37 p.m. The next meeting of the Vending Oversight Committee is scheduled for Wednesday, May 28, 2008, 5 p.m., City-County Building, room 108.
