#### LIQUOR AND/OR BEER ORIGINAL SUPPLEMENTAL FORM

### Paragraph 9 - Business Description including hours of operation and if entertainment is part of your venue, what type:

The business will be a restaurant with a bar area. The restaurant will serve a selection of ethnic and American food. Food will be served in the restaurant and bar area from 11:30 a.m. to 9:00 p.m. Monday-Thursday and Sunday, and 11:30 a.m. to 10:00 p.m. Friday and Saturday. Food will also be served in the bar area from 9:00 p.m. to 12:00 a.m. Monday-Thursday and Sunday, and 10:00 p.m. to 12:00 a.m. Friday and Saturday. Only a limited selection of appetizers and snacks will be served in the bar area.

Disc jockeys will provide Latin music entertainment in the bar area from 9:00 p.m. to 2:00 a.m. on Friday and Saturday nights, and occasionally on Thursday nights.

# Paragraph 10 - Detailed <u>written</u> description of building, including overall dimensions, seating arrangements, capacity, bar size and all areas where alcohol beverages are to be sold and stored:

The landlord of 6722 Odana Road did not have a floor plan available for the premises. A copy of the floor plan has been requested from the Building Inspection Unit and will be provided as soon as possible, along with a written response to this question. This response cannot be completed prior to obtaining the floor plan.

### Paragraph 12 - Describe existing parking and how parking lot is to be monitored.

There will be approximately 80 parking spaces dedicated to the licensed premises and the computer store that is in the same building as the licensed premises. Patrons of the licensed premises can also use the parking spaces behind the shopping center immediately east of the licensed premises.

With regard to how the parking lot will be monitored, when disc jockey entertainment is being provided, security staff will regularly patrol the immediate exterior of the building. When disc jockey entertainment is not being provided, management and staff will periodically inspect the parking lot for litter and other issues

### Paragraph 13 - Describe your management experience, staffing levels, duties and employee training:

Su-Hua Kuo and Wen-Bin Kuo have been working in the restaurant business since 1992 and have been involved in providing disc jockey entertainment since 2000.

The following is an estimate of the staffing levels:

- 1 5-6 wait staff;
- 2 6 kitchen staff (cooks, dishwashers);
- 3. 8 bartenders; and
- 5 persons to provide security and check identification cards (3 of which will be provided by a security company).

Employee training consists of on-site training by management and a written employee manual. The bartenders that are hired have a bartender's license and most have already completed the beverage server training course. Management will familiarize the bartenders with the laws relating to service of alcohol and unruly patrons, if they are not already familiar with them.

### Paragraph 16 - What type of food will you be serving, if any?

The restaurant will serve a selection of ethnic and American food. The full restaurant menu will be available from 11:30 a.m. to 9:00 p.m. Monday-Thursday and Sunday, and 11:30 a.m. to 10:00 p.m. Friday and Saturday. After 9:00 p.m. on Monday-Thursday and Sunday, and after 10:00 p.m. on Friday and Saturday, only a limited menu consisting of appetizers and snacks will be available.

#### Paragraph 18 - Describe your target market.

The target market for the restaurant are individuals and families from the Madison area. The target market for the disc jockey entertainment are Latino individuals 30-50 years of age.

## Paragraph 34 - Describe how you plan to advertise/promote your business. What products will you be advertising?

The business will be advertised in the telephone book, local newspapers and local magazines. Also, advertisements will be made on the radio. The business will advertise food, alcohol and disc jockey entertainment.
